

ORDINANCE NO. _____-2012

AN ORDINANCE AMENDING SECTIONS 21-5(2), 22-5(2) AND 23-5(b) OF THE CODE OF ORDINANCES ABOLISHING VACANT AND UNFUNDED POSITIONS IN WITHIN VARIOUS DEPARTMENTS AND DIVISIONS OF THE URBAN COUNTY GOVERNMENT.
