

ORDINANCE NO. 147 -2022

AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO PROVIDE \$1,000,000 FOR THE JEFFERSON STREET VIADUCT PROJECT AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO 0024.

WHEREAS, it is necessary and proper to amend the budgets of the Lexington-Fayette Urban County Government to provide \$1,000,000 for the Jefferson Street Viaduct project:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to provide \$1,000,000 for the Jefferson Street Viaduct project, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
