

A RESOLUTION CHANGING THE PROPERTY ADDRESS NUMBER OF 1174 ACCORD DRIVE TO 1170 ACCORD DRIVE, 4994-5002 OLD VERSAILLES ROAD TO 4996 OLD VERSAILLES ROAD, 3408 SUTHERLAND DRIVE TO 3408 SUTHERLAND DRIVE UNIT 100 AND CHANGING THE STREET NAMES AND PROPERTY ADDRESS NUMBERS OF 420-430 DE ROODE STREET TO 600 EMMALINE LANE, 410 DE ROODE STREET TO 405 CHAIR AVENUE, 418 DE ROODE STREET TO 425 CHAIR AVENUE, 3280 CLAYS MILL ROAD TO 695 VINCENT WAY, 4001 IRON WORKS PIKE TO 4175 CIGAR LANE, 2331 BUENA VISTA ROAD TO 2270 ELKHORN ROAD, 3948 WESTBROOK DRIVE TO 1124 FOLEYS RETREAT, ALL EFFECTIVE THIRTY (30) DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the property address numbers of the following property be and hereby are changed as follows:

(a) Accord Drive

<u>Current</u>	<u>New</u>
1174 Accord Drive	1170 Accord Drive

(b) Old Versailles Road

<u>Current</u>	<u>New</u>
4994-5002 Old Versailles Road	4996 Old Versailles Road

(c) Sutherland Drive

<u>Current</u>	<u>New</u>
3408 Sutherland Drive	3408 Sutherland Drive Unit 100

Section 2 – That the street names and property address numbers of the following properties be and hereby are changed as follows:

- (a) De Roode Street: That the name of De Roode Street located at 420-430 is changed to Emmaline Lane and the name of De Roode Street located at 410 and 418 is changed to Chair Avenue and the following number changes are made:

<u>Current</u>	<u>New</u>
420-430 De Roode Street	600 Emmaline Lane
410 De Roode Street	405 Chair Avenue
418 De Roode Street	425 Chair Avenue

- (b) Clays Mill Road: That the name of Clays Mill Road located at 3280 is changed to Vincent Way and the following number changes are made:

<u>Current</u>	<u>New</u>
3280 Clays Mill Road	695 Vincent Way

- (c) Iron Works Pike: That the name of Iron Works Pike located at 4001 is changed to Cigar Lane and the following number changes are made:

<u>Current</u>	<u>New</u>
4001 Iron Works Pike	4175 Cigar Lane

- (d) Buena Vista Road: That the name of Buena Vista Road located at 2331 is changed to Elkhorn Road and the following number changes are made:

<u>Current</u>	<u>New</u>
2331 Buena Vista Road	2270 Elkhorn Road

- (e) Westbrook Road: That the name of Westbrook Road located at 3948 is changed to Foleys Retreat and the following number changes are made:

<u>Current</u>	<u>New</u>
3948 Westbrook Drive	1124 Foleys Retreat

Section 3 - That this Resolution shall be effective thirty (30) days from passage.
