



LEGAL DESCRIPTION

Land Description

All of that tract or parcel of land located in the city of Lexington, Kentucky, in the county of Fayette, in the Commonwealth of Kentucky, and being more particularly described and designated as follows:

RICHMOND AVENUE, AT A POINT IN THE NORTHEASTERN RIGHT-OF-WAY LINE OF RICHMOND AVENUE, WHERE said right-of-way line is intersected by the northwesterly right-of-way line of WHITE STREET, said point being monumented by an iron pin, thence, following the line so monumented, westwardly along RICHMOND AVENUE, running 15.00 feet to a point, said point being at the connection with the northwesterly right-of-way line of WHITE STREET, thence, following said right-of-way line, straight, 320.00 feet to a point in the rear property line of 345 Owsley Avenue, 10.00 feet 2156, PG 534, said point being monumented by an iron pin, thence, following said property line and continuing with the rear property line of 345 Owsley Avenue (O. B. 1937, PC 1921), straight, 40.00 feet, thence, back to the point being monumented by an iron pin, at the intersection with the northwesterly right-of-way line of WHITE STREET, thence, following said right-of-way line, straight, 320.00 feet to the point of beginning, following and continuing a curve and then straight, 13.00 to a point (O. B. 1930, PC 1921).
