## Request for Proposals

---

The Lexington-Fayette Urban County Government hereby requests proposals for **RFP #9-2021 Traffic Signal Retiming Project** to be provided in accordance with terms, conditions and specifications established herein.

Sealed proposals will be received through Ion Wave until **2:00 PM**, prevailing local time, on **May 3, 2021**. All forms and information requested in RFP must be included and attached in Response Attachments tab in Ion Wave.

Proposals received after the date and time set for opening proposals will not be accepted. It is the sole responsibility of the Proposer to assure that his/her proposal is submitted in Ion Wave before the date and time set for opening proposals.

Proposals, once submitted, may not be withdrawn for a period of sixty (60) calendar days.

The Lexington-Fayette Urban County Government reserves the right to reject any or all proposals, and to waive technicalities and informalities when such waiver is determined by the Lexington-Fayette Urban County Government to be in its best interest.

Signature of this proposal by the Proposer constitutes acceptance by the Proposer of terms, conditions and requirements set forth herein.

Minor exceptions may not eliminate the proposal. Any exceptions to the specifications established herein shall be listed in detail on a separate sheet and attached hereto. The Lexington-Fayette Urban County Government shall determine whether any exception is minor.

The Lexington-Fayette Urban County Government encourages the participation of minority- and women-owned businesses in Lexington-Fayette Urban County Government contracts. This proposal is subject to Affirmative Action requirements attached hereto.

***Please do not contact any LFUCG staff member or any other person involved in the selection process other than the designated contact person(s) regarding the project contemplated under this RFP while this RFP is open and a selection has not been finalized. Any attempt to do so may result in disqualification of the firm's submittal for consideration.***

## **Laws and Regulations**

All applicable state laws, municipal ordinances and regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

## **Equal Employment Opportunity**

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, religion, sex (including pregnancy, sexual orientation or gender identity), national origin, disability, age, genetic information, political affiliation, or veteran status, and to promote equal employment through a positive, continuing program from itself and each of its sub-contracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

## **Kentucky Equal Employment Opportunity Act**

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

- (1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;
- (2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;
- (3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and
- (4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers' representative of the contractor's commitments under the nondiscrimination clauses."

The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

- (1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.
- (2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to

his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

(1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.

(2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the contractor complies in full with the requirements of KRS 45.560 to 45.640.

(3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as special conditions in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available work-force in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

### **LFUCG Non-Appropriation Clause**

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without

penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

### **Contention Process**

Vendors who respond to this invitation have the right to file a notice of contention associated with the RFP process or to file a notice of appeal of the recommendation made by the Director of Central Purchasing resulting from this invitation.

Notice of contention with the RFP process must be filed within 3 business days of the bid/proposal opening by (1) sending a written notice, including sufficient documentation to support contention, to the Director of the Division of Central Purchasing or (2) submitting a written request for a meeting with the Director of Central Purchasing to explain his/her contention with the RFP process. After consulting with the Commissioner of Finance the Chief Administrative Officer and reviewing the documentation and/or hearing the vendor, the Director of Central Purchasing shall promptly respond in writing findings as to the compliance with RFP processes. If, based on this review, a RFP process irregularity is deemed to have occurred the Director of Central Purchasing will consult with the Commissioner of Finance, the Chief Administrative Officer and the Department of Law as to the appropriate remedy.

Notice of appeal of a RFP recommendation must be filed within 3 business days of the RFP recommendation by (1) sending a written notice, including sufficient documentation to support appeal, to the Director, Division of Central Purchasing or (2) submitting a written request for a meeting with the Director of Central Purchasing to explain his appeal. After reviewing the documentation and/or hearing the vendor and consulting with the Commissioner of Finance and the Chief Administrative Officer, the Director of Central Purchasing shall in writing, affirm or withdraw the recommendation.

### **SELECTION CRITERIA:**

1. Specialized experienced and technical competence of the person or firm (including a joint venture or association) with the type of service required (20%)
2. Evaluation of the approach and methodology described in the submitted proposal (20%)
3. Familiarity with the details of this specific project (20%)
4. Capacity of the person or firm to perform the work, including any specialized services, within the time limitations (15%)
5. Past record and performance on contracts with the LFUCG or other governmental agencies and private industry with respect to such factors as control of cost, quality of work and ability to meet scheduling (15%)
6. Degree of local employment to be provided by the person or firm (10%)

Proposals shall contain the appropriate information necessary to evaluate based on these criteria. A committee composed of government employees as well as representatives of relevant user groups will evaluate the proposals.

# EQUAL OPPORTUNITY AGREEMENT

## Standard Title VI Assurance

The Lexington Fayette-Urban County Government, (hereinafter referred to as the "Recipient") hereby agrees that as a condition to receiving any Federal financial assistance from the U.S. Department of Transportation, it will comply with Title VI of the Civil Rights Act of 1964, 78Stat.252, 42 U.S.C. 2000d-4 (hereinafter referred to as the "Act"), and all requirements imposed by or pursuant to Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, (49 CFR, Part 21) Nondiscrimination in Federally Assisted Program of the Department of Transportation – Effectuation of Title VI of the Civil Rights Act of 1964 (hereinafter referred to as the "Regulations") and other pertinent directives, no person in the United States shall, on the grounds of race, color, national origin, sex, age (over 40), religion, sexual orientation, gender identity, veteran status, or disability be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which the Recipient receives Federal financial assistance from the U.S. Department of Transportation, including the Federal Highway Administration, and hereby gives assurance that will promptly take any necessary measures to effectuate this agreement. This assurance is required by subsection 21.7(a) (1) of the Regulations.

## The Law

- Title VII of the Civil Rights Act of 1964 (amended 1972) states that it is unlawful for an employer to discriminate in employment because of race, color, religion, sex, age (40-70 years) or national origin.
- Executive Order No. 11246 on Nondiscrimination under Federal contract prohibits employment discrimination by contractor and sub-contractor doing business with the Federal Government or recipients of Federal funds. This order was later amended by Executive Order No. 11375 to prohibit discrimination on the basis of sex.
- Section 503 of the Rehabilitation Act of 1973 states:

*The Contractor will not discriminate against any employee or applicant for employment because of physical or mental handicap.*

- Section 2012 of the Vietnam Era Veterans Readjustment Act of 1973 requires Affirmative Action on behalf of disabled veterans and veterans of the Vietnam Era by contractors having Federal contracts.
- Section 206(A) of Executive Order 12086, Consolidation of Contract Compliance Functions for Equal Employment Opportunity, states:

*The Secretary of Labor may investigate the employment practices of any Government contractor or sub-contractor to determine whether or not the contractual provisions specified in Section 202 of this order have been violated.*

\*\*\*\*\*

The Lexington-Fayette Urban County Government practices Equal Opportunity in recruiting, hiring and promoting. It is the Government's intent to affirmatively provide employment opportunities for those individuals who have previously not been allowed to enter into the mainstream of society. Because of its importance to the local Government, this policy carries the full endorsement of the Mayor, Commissioners, Directors and all supervisory personnel. In following this commitment to Equal Employment Opportunity and because the Government is the benefactor of the Federal funds, it is both against the Urban County Government policy and illegal for the Government to let contracts to companies which knowingly or unknowingly practice discrimination in their employment practices. Violation of the above mentioned ordinances may cause a contract to be canceled and the contractors may be declared ineligible for future consideration.

Notice of requirement for Affirmative Action to ensure Equal Employment Opportunities and Disadvantaged Business Enterprises (DBE) Contract participation. Disadvantaged Business Enterprises (DBE) consists of Minority-Owned Business Enterprises (MBE) and Woman-Owned Business Enterprises (WBE).

The Lexington-Fayette Urban County Government has set a goal that not less than ten percent (10%) of the total value of this Contract be subcontracted to Disadvantaged Business Enterprises, which is made up of MBEs and WBEs. The Lexington Fayette Urban County Government also has set a goal that not less than three percent (3%) of the total value of this Contract be subcontracted to Veteran-owned Small Businesses. The goal for the utilization of Disadvantaged Business Enterprises as well Veteran –owned Small Businesses as subcontractors is a recommended goal. Contractor(s) who fail to meet such goal will be expected to provide written explanations to the Director of the Division of Purchasing of efforts they have made to accomplish the recommended goal, and the extent to which they are successful in accomplishing the recommended goal will be a consideration in the procurement process. Depending on the funding source, other DBE goals may apply.

**MWDBE PARTICIPATION GOALS**

**A. GENERAL**

- 1) The LFUCG request all potential contractors to make a concerted effort to include Minority-Owned (MBE), Woman-Owned (WBE), Disadvantaged (DBE) Business Enterprises and Veteran-Owned Small Businesses (VOSB) as subcontractors or suppliers in their bids.
- 2) Toward that end, the LFUCG has established 10% of total procurement costs as a Goal for participation of Minority-Owned, Woman-Owned and Disadvantaged Businesses on this contract.
- 3) **It is therefore a request of each Bidder to include in its bid, the same goal (10%) for MWDBE participation and other requirements as outlined in this section.**
- 4) The LFUCG has also established a 3% of total procurement costs as a Goal for participation for of Veteran-Owned Businesses.
- 5) **It is therefore a request of each Bidder to include in its bid, the same goal (3%) for Veteran-Owned participation and other requirements as outlined in this section.**

**B. PROCEDURES**

- 1) The successful bidder will be required to report to the LFUCG, the dollar amounts of all payments submitted to Minority-Owned, Woman-Owned or Veteran-Owned subcontractors and suppliers for work done or materials purchased for this contract. (See Subcontractor Monthly Payment Report)
- 2) Replacement of a Minority-Owned, Woman-Owned or Veteran-Owned subcontractor or supplier listed in the original submittal must be requested in writing and must be accompanied by documentation of Good Faith Efforts to replace the subcontractor / supplier with another MWDBE Firm; this is subject to approval by the LFUCG. (See LFUCG MWDBE Substitution Form)
- 3) For assistance in identifying qualified, certified businesses to solicit for potential contracting opportunities, bidders may contact:
  - a) The Lexington-Fayette Urban County Government, Division of Central Purchasing (859-258-3320)
- 4) The LFUCG will make every effort to notify interested MWDBE and Veteran-Owned subcontractors and suppliers of each Bid Package, including information on the scope of work, the pre-bid meeting time and location, the bid date, and all other pertinent information regarding the project.

**C. DEFINITIONS**

- 1) A Minority-Owned Business Enterprise (MBE) is defined as a business which is certified as being at least 51% owned, managed and controlled by persons of African American, Hispanic, Asian, Pacific Islander, American Indian or Alaskan Native Heritage.
- 2) A Woman-Owned Business Enterprise (WBE) is defined as a business which is certified as being at least 51% owned, managed and controlled by one or more women.

- 3) A Disadvantaged Business (DBE) is defined as a business which is certified as being at least 51% owned, managed and controlled by a person(s) that are economically and socially disadvantaged.
- 4) A Veteran-Owned Small Business (VOSB) is defined as a business which is certified as being at least 51% owned, managed and controlled by a veteran and/or a service disabled veteran.
- 5) Good Faith Efforts are efforts that, given all relevant circumstances, a bidder or proposer actively and aggressively seeking to meet the goals, can reasonably be expected to make. In evaluating good faith efforts made toward achieving the goals, whether the bidder or proposer has performed the efforts outlined in the Obligations of Bidder for Good Faith Efforts outlined in this document will be considered, along with any other relevant factors.

#### D. OBLIGATION OF BIDDER FOR GOOD FAITH EFFORTS

- 1) **The bidder shall make a Good Faith Effort to achieve the Participation Goal for MWDBE and Veteran-Owned subcontractors/suppliers. The failure to meet the goal shall not necessarily be cause for disqualification of the bidder; however, bidders not meeting the goal are required to furnish with their bids written documentation of their Good Faith Efforts to do so.**
- 2) Award of Contract shall be conditioned upon satisfaction of the requirements set forth herein.
- 3) The Form of Proposal includes a section entitled "MWDBE Participation Form". The applicable information must be completed and submitted as outlined below.
- 4) **Failure to submit this information as requested may be cause for rejection of bid or delay in contract award.**

#### E. DOCUMENTATION REQUIRED FOR GOOD FAITH EFFORTS

- 1) Bidders reaching the Goal are required to submit only the MWDBE Participation Form." The form must be fully completed including names and telephone number of participating MWDBE firm(s); type of work to be performed; estimated value of the contract and value expressed as a percentage of the total Lump Sum Bid Price. The form must be signed and dated, and is to be submitted with the bid.
- 2) Bidders not reaching the Goal must submit the "MWDBE Participation Form", the "Quote Summary Form" and a written statement documenting their Good Faith Effort to do so. If bid includes no MWDBE and/or Veteran participation, bidder shall enter "None" on the subcontractor / supplier form). In addition, the bidder must submit written proof of their Good Faith Efforts to meet the Participation Goal:
  - a. Advertised opportunities to participate in the contract in at least two (2) publications of general circulation media; trade and professional association publications; small and minority business or trade publications; and publications or trades targeting minority, women and disadvantaged businesses not less than fifteen (15) days prior to the deadline for submission of bids to allow MWDBE firms and Veteran-Owned businesses to participate.
  - b. Included documentation of advertising in the above publications with the bidders good faith efforts package

- c. Attended LFUCG Central Purchasing Economic Inclusion Outreach event
- d. Attended pre-bid meetings that were scheduled by LFUCG to inform MWDBEs and/or Veteran-Owned businesses of subcontracting opportunities
- e. Sponsored Economic Inclusion event to provide networking opportunities for prime contractors and MWDBE firms and Veteran-Owned businesses.
- f. Requested a list of MWDBE and/or Veteran subcontractors or suppliers from LFUCG and showed evidence of contacting the companies on the list(s).
- g. Contacted organizations that work with MWDBE companies for assistance in finding certified MWDBE firms and Veteran-Owned businesses to work on this project. Those contacted and their responses should be a part of the bidder's good faith efforts documentation.
- d. Sent written notices, by certified mail, email or facsimile, to qualified, certified MWDBEs and/or Veteran-Owned businesses soliciting their participation in the contract not less than seven (7) days prior to the deadline for submission of bids to allow them to participate effectively.
- e. Followed up initial solicitations by contacting MWDBEs and Veteran-Owned Businesses to determine their level of interest.
- j. Provided the interested MWDBE firm and/or Veteran-Owned business with adequate and timely information about the plans, specifications, and requirements of the contract.
- k. Selected portions of the work to be performed by MWDBE firms and/or Veteran-Owned businesses in order to increase the likelihood of meeting the contract goals. This includes, where appropriate, breaking out contract work items into economically feasible units to facilitate MWDBE and Veteran participation, even when the prime contractor may otherwise perform these work items with its own workforce
- l. Negotiated in good faith with interested MWDBE firms and Veteran-Owned businesses not rejecting them as unqualified without sound reasons based on a thorough investigation of their capabilities. Any rejection should be so noted in writing with a description as to why an agreement could not be reached.
- m. Included documentation of quotations received from interested MWDBE firms and Veteran-Owned businesses which were not used due to uncompetitive pricing or were rejected as unacceptable and/or copies of responses from firms indicating that they would not be submitting a bid.
- n. Bidder has to submit sound reasons why the quotations were considered unacceptable. The fact that the bidder has the ability and/or desire to perform the contract work with its own forces will not be considered a sound reason for rejecting a MWDBE and/or Veteran-Owned business's quote. Nothing in this provision shall be construed to require the bidder to accept unreasonable quotes in order to satisfy MWDBE and Veteran goals.

## **GENERAL PROVISIONS**

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

The Respondent agrees to comply with all statutes, rules, and regulations governing safe and healthful working conditions, including the Occupational Health and Safety Act of 1970, *29 U.S.C. 650 et. seq.*, as amended, and KRS Chapter 338. The Respondent also agrees to notify the LFUCG in writing immediately upon detection of any unsafe and/or unhealthful working conditions at the job site. The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.
3. Addenda: All addenda and IonWave Q&A, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. 9. 10. Ambiguity, Conflict or other Errors in RFP: If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
11. Agreement to Bid Terms: In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. 12. #### A. Termination for Cause

  - (d) Failure to diligently advance the work under a contract for construction services;
  - (e) The filing of a bankruptcy petition by or against the contractor; or
  - (f) Actions that endanger the health, safety or welfare of the LFUCG or its citizens.

#### B. At Will Termination

Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent, Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

13. **Assignment of Contract:** The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. Any purported assignment or subcontract in violation hereof shall be void. It is expressly acknowledged that LFUCG shall never be required or obligated to consent to any request for assignment or subcontract; and further that such refusal to consent can be for any or no reason, fully within the sole discretion of LFUCG.
14. **No Waiver:** No failure or delay by LFUCG in exercising any right, remedy, power or privilege hereunder, nor any single or partial exercise thereof, nor the exercise of any other right, remedy, power or privilege shall operate as a waiver hereof or thereof. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
15. **Authority to do Business:** The Respondent must be a duly organized and authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. The Respondent will provide LFUCG with a copy of a corporate resolution authorizing this action and a letter from an attorney confirming that the proposer is authorized to do business in the State of Kentucky if requested. All proposals must

be signed by a duly authorized officer, agent or employee of the Respondent.

16. **Governing Law:** This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. In the event of any proceedings regarding this Contract, the Parties agree that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division. All parties expressly consent to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to this Contract or any rights or obligations arising thereunder. Service of process may be accomplished by following the procedures prescribed by law.
17. **Ability to Meet Obligations:** Respondent affirmatively states that there are no actions, suits or proceedings of any kind pending against Respondent or, to the knowledge of the Respondent, threatened against the Respondent before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of Respondent to perform its obligations under this Contract, or which question the legality, validity or enforceability hereof or thereof.
18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
19. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.
20. **INDEMNIFICATION AND HOLD HARMLESS PROVISION**

- (1) It is understood and agreed by the parties that Contractor hereby assumes the entire responsibility and liability for any and all damages to persons or property caused by or resulting from or arising out of any act or omission on the part of Contractor or its employees, agents, servants, owners, principals, licensees, assigns or subcontractors of any tier (hereinafter "CONTRACTOR") under or in connection with this agreement and/or the provision of goods or services and the performance or failure to perform any work required thereby.
- (2) CONTRACTOR shall indemnify, save, hold harmless and defend the Lexington-Fayette Urban County Government and its elected and appointed officials, employees, agents, volunteers, and successors in interest (hereinafter "LFUCG") from and against all liability, damages, and losses, including but not limited to, demands, claims, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees that are in any way incidental to or connected with, or that arise or are alleged to have arisen, directly or indirectly, from or by CONTRACTOR's performance or breach of the agreement and/or the provision of goods or services provided that: (a) it is attributable to personal injury, bodily injury, sickness, or death, or to injury to or destruction of property (including the loss of use resulting therefrom), or to or from the negligent acts, errors or omissions or willful misconduct of the CONTRACTOR; and (b) not caused solely by the active negligence or willful misconduct of LFUCG.
- (3) In the event LFUCG is alleged to be liable based upon the above, CONTRACTOR shall defend such allegations and shall bear all costs, fees and expenses of such defense, including but not limited to, all reasonable attorneys' fees and expenses, court costs, and expert witness fees and expenses, using attorneys approved in writing by LFUCG, which approval shall not be unreasonably withheld.
- (4) These provisions shall in no way be limited by any financial responsibility or insurance requirements, and shall survive the termination of this agreement.
- (5) LFUCG is a political subdivision of the Commonwealth of Kentucky. CONTRACTOR acknowledges and agrees that LFUCG is unable to provide indemnity or otherwise save, hold harmless, or defend the CONTRACTOR in any manner.

**FINANCIAL RESPONSIBILITY**

BIDDER/CONTRACTOR understands and agrees that it shall demonstrate the ability to assure compliance with the above Indemnity provisions and these other risk management provisions prior to final acceptance of its bid and the commencement of any work or provision of goods.

**INSURANCE REQUIREMENTS**

YOUR ATTENTION IS DIRECTED TO THE INSURANCE REQUIREMENTS BELOW, AND YOU MAY NEED TO CONFER WITH YOUR INSURANCE AGENTS, BROKERS, OR CARRIERS TO DETERMINE IN ADVANCE OF SUBMISSION OF A RESPONSE THE AVAILABILITY OF THE INSURANCE COVERAGES AND ENDORSEMENTS REQUIRED HEREIN. IF YOU FAIL TO COMPLY WITH THE INSURANCE REQUIREMENTS BELOW, YOU MAY BE DISQUALIFIED FROM AWARD OF THE CONTRACT.

Required Insurance Coverage

BIDDER/CONTRACTOR shall procure and maintain for the duration of this contract the following or equivalent insurance policies at no less than the limits shown below and cause its subcontractors to maintain similar insurance with limits acceptable to LFUCG in order to protect LFUCG against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work hereunder by CONTRACTOR. The cost of such insurance shall be included in any bid:

- a. All Certificates of Insurance forms used by the insurance carrier shall be properly filed and approved by the Department of Insurance for the Commonwealth of Kentucky (DOI). LFUCG shall be named as an additional insured in the General Liability Policy and Commercial Automobile Liability Policy using the Kentucky DOI approved forms.
- b. The General Liability Policy shall be primary to any insurance or self-insurance retained by LFUCG.
- c. The General Liability Policy shall include Premises and Operations coverage unless it is deemed not to apply by LFUCG.
- d. The General Liability Policy shall include Employment Practices Liability coverage or an endorsement in a minimum amount of \$1 million unless it is deemed not to apply by LFUCG.
- e. The Policy shall include Umbrella/Excess Liability coverage in the amount of \$2 million per occurrence, \$2 million aggregate, unless it is deemed not to apply by LFUCG.
- f. LFUCG shall be provided at least 30 days advance written notice via certified mail, return receipt requested, in the event any of the required policies are canceled or non-renewed.
- g. Said coverage shall be written by insurers acceptable to LFUCG and shall be in a form acceptable to LFUCG. Insurance placed with insurers with a rating classification of no less than Excellent (A or A-) and a financial size category of no less than VIII, as defined by the most current Best's Key Rating Guide shall be deemed automatically acceptable.

Renewals

After insurance has been approved by LFUCG, evidence of renewal of an expiring policy must be submitted to LFUCG, and may be submitted on a manually signed renewal endorsement form. If the policy or carrier has changed, however, new evidence of coverage must be submitted in accordance with these Insurance Requirements.

#### Deductibles and Self-Insured Programs

**IF YOU INTEND TO SUBMIT A SELF-INSURANCE PLAN IT MUST BE FORWARDED TO LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, DIVISION OF RISK MANAGEMENT, 200 EAST MAIN STREET, LEXINGTON, KENTUCKY 40507 NO LATER THAN A MINIMUM OF FIVE (5) WORKING DAYS PRIOR TO THE RESPONSE DATE.**

Self-insurance programs, deductibles, and self-insured retentions in insurance policies are subject to separate approval by Lexington-Fayette Urban County Government's Division of Risk Management, upon review of evidence of BIDDER/CONTRACTOR's financial capacity to respond to claims. Any such programs or retentions must provide LFUCG with at least the same protection from liability and defense of suits as would be afforded by first-dollar insurance coverage

#### Safety and Loss Control

#### Right to Review, Audit and Inspect

CONTRACTOR understands and agrees that LFUCG may review, audit and inspect any and all of its records and operations to insure compliance with these Insurance Requirements.

#### **DEFAULT**

BIDDER/CONTRACTOR understands and agrees that the failure to comply with any of these insurance, safety, or loss control provisions shall constitute default and that LFUCG may elect at its option any single remedy or penalty or any combination of remedies and penalties, as available, including but not limited to purchasing insurance and charging BIDDER/CONTRACTOR for any such insurance premiums purchased, or suspending or terminating the work.

## Traffic Signal Timing Plans

### **General Project Description ...**

The Lexington-Fayette Urban County Government, Division of Traffic Engineering desires a consultant pre-qualified with KYTC in Traffic Engineering Services to develop (11) new traffic signal timing plans for each intersection along New Circle Road in Lexington so as to achieve optimized traffic flow, reduce emissions and enhance safety. The consultant shall provide a detailed description as to the methodology used in defining the recommended traffic signal timing plans.

### **Intersections for Review ...**

#### New Circle Road (KY4) – (17 intersections)

- New Circle Road at Boardwalk/Colesbury Circle
- New Circle Road at Russell Cave Road
- New Circle Road at Broadway
- New Circle Road at Limestone
- New Circle Road at Bryan Station Road
- New Circle Road at Meadow Lane
- New Circle Road at Floyd Drive
- New Circle Road at Industry Road
- New Circle Road at Eastland Parkway
- New Circle Road at Winchester Road
- New Circle Road at Jingle Bell Lane/Pridemore Court
- New Circle Road at Trade Center Drive
- New Circle Road at Family Circle
- New Circle Road at Liberty Road
- New Circle Road at Young Drive
- New Circle Road at Palumbo Drive
- New Circle Road at Woodhill Drive

Once the project is satisfactorily completed and the new timing plans are in full operation, four (4) final hardcopy reports, including a USB drive with all of the Synchro runs in each report shall be submitted containing all information relative to the project (including all model data, Excel spreadsheets, Travel time data, traffic counts, etc.). All final reports shall be submitted to LFUCG no later than March 30, 2022. Any exception taken with respect to the time designation should be noted on the submittal.

The LFUCG reserves the right to award the contract for this project on the basis of demonstrated experience with like projects by the Consultant(s) submitting the proposals.

Each timing plan for the corridor should be broken out within the proposal such that the costs and action plans are clearly defined independently from one another. A bid for the entire project should be included along with a separate bid broken out for each timing plan or timing pattern for the corridor.

### **General Information Required in Proposal ...**

The Consultant shall provide all pertinent information relative to past and current work involving the optimization and coordination of traffic signals, with specific emphasis on major high-volume corridors in congested areas with conflicting traffic demands. The LFUCG reserves the right to weight experience based on similar component work as is used within our traffic signal system (e.g. familiarity with MaxView traffic control software, 2070 controllers, MaxTime controller firmware, radial arterial network systems, and others).

### **Specific Services Requested ...**

#### **Timing Plan Specifics**

The Consultant shall be responsible for recommending and providing the Division of Traffic Engineering eleven (11) new timing plans or variable timing schemes for each intersection from the project intersection list to achieve optimized traffic flow along the specified corridors. The general guidelines for the timing plans are to develop plans during the following times of day and days of week

Plan 1 Morning	(7:00am to 9:00am)	–	Weekday
Plan 2 Morning Off Peak	(9:00am to 11:30am)	–	Weekday
Plan 3 Midday	(11:30am to 2:00pm)	–	Weekday
Plan 4 Midday Off Peak	(2:00pm to 3:00pm)	–	Weekday
Plan 5 Evening	(3:00pm to 6:00pm)	–	Weekday
Plan 6 Evening Off Peak	(6:00pm to 11:00pm)	–	Weekday
Plan 11 Morning	(8:00am to 11:00am)	–	Saturday
Plan 13 Midday	(11:00am to 4:00pm)	–	Saturday
Plan 15 Evening	(4:00pm to 10:00pm)	–	Saturday
Plan 21 Morning	(9:00am to 11:20am)	–	Sunday
Plan 25 Afternoon/Evening	(11:20am to 10:00pm)	–	Sunday

Of the plans defined above, the natural breaks in traffic volumes defined within the specific traffic counts for each route were weighed in determining the actual time schedules for each respective timing plan. The times noted above were used as a guide and not viewed as absolutes since the natural volume breaks in demands on the system may determine the schedule timing. Likewise there may also be natural breaks in groupings of signals along the corridor. Any deviation related to scheduling will require LFUCG approval. The consultant will also need to account for special circumstances at each

intersection that may occur during the different timing periods, such as school timing, major business starting or ending shifts, or any other event that may cause differences in normal patterns on a regularly occurring basis.

If natural volume breaks in demands on the system determines that fewer than (11) timing plans are needed for regular daytime operations of the corridor, LFUCG reserves the right require the consultant to produce other arterial event plans or overnight plans in lieu of the unneeded daytime plans based on projected traffic volumes. The total number of timing plans required however, will not exceed (11) timing plans per intersection.

### **Traffic Count Data Specifics ...**

The Consultant shall provide a separate line item within their Proposal for the collection of vehicular volumes along the corridor. All data collection bids shall be separated from the signal timing proposals such that it is apparent as to the cost proposed for this effort. LFUCG reserves the right to provide turning movement counts at select intersections. Furthermore, LFUCG reserves the right to reject any and all data collection bids based on cost and qualifications.

Traffic count data is to be obtained using a 15-minute interval and shall include directional volume and turning movements for each lane for each approach. Actual traffic counts for all signalized intersections for the routes are required. Software derived volumes and turning movements for uncounted signalized intersections will only be accepted (such as traffic counts projected by software based on counts of nearby intersections) if allowed by LFUCG. The counts shall be submitted in the final deliverables as xlsx, and pdf formats. The weekday traffic count volume data must be conducted during a typical weekday on Tuesday, Wednesday, or Thursday while Fayette County Public Schools and the University of Kentucky are both physically in session. The weekend traffic count for volume data must be conducted during a typical weekend on both Saturday and Sunday while Fayette County Public Schools and the University of Kentucky are both physically in session. All counts are to be conducted under normal conditions (i.e. no lane closures, no Holidays or other major traffic impacts). Weekday traffic data collection shall be conducted between the hours of 6:00am-12:00am. Saturday and Sunday traffic data collection shall be conducted between the hours of 8:00am-12:00am. If major events are scheduled in the project vicinity (e.g. Keeneland, UK Football, UK Basketball, Sweet Sixteen), approval needs to be given from LFUCG prior to collecting such data. Traffic count data shall be analyzed such as to determine the major flow of traffic to determine the progression patterns. Any exceptions must be approved by LFUCG.

The Consultant shall gather travel time analytic data showing existing conditions upon notice to proceed under contract. Following the implementation and adjustments to the new recommended timing plans, documentation during the same periods (i.e. same day of week and time of day) shall be recorded and provided in the same manner to show improvements in travel conditions and matched the final time/space diagrams submitted.

## **Traffic Analysis and Simulation Specifics...**

The Consultant shall use CUBIC | Traffware Synchro version 11 (or newer with approval) for the traffic analysis software in the creation of timing plans. Calculated and modified time/space diagrams for each timing plan shall be submitted. The Consultant shall measure the saturation flow rates of each arterial as outlined in the Highway Capacity Manual, so that a well calibrated model can be documented and used from the onset of the project. Existing timing plans shall be modeled and used as a baseline for improvements using SimTraffic. The final product shall include all Synchro files and runs incorporated into our system, as well as the Synchro models in their entirety.

Traffic volumes used for modeling traffic should be more reflective of travel demand and not just traffic that is served. Traffic corridors may be over capacity during certain times of the day, therefore the consultant should make efforts to time the corridors to better service traffic demand rather than only traffic that is counted if entire queues are not currently being serviced each signal cycle.

Each corridor has a Synchro 11 compatible base model that will be provided by the LFUCG, as will all current timing tables as required to establish proper model calibration to existing conditions. Current Synchro models may need to have updates made by the consultant to reflect current roadway geometry and conditions. A suitcase tester and a 2070 controller can be made available to the Consultant(s) to test timing parameters prior to implementation at the LFUCG Division of Traffic Engineering office.

The Consultant shall provide a plan of action that includes (at a minimum):

- 1) a licensed engineer in the Commonwealth of Kentucky as a project manager (with contact information)
- 2) a critical path schedule for each route individually
- 3) a detailed meeting schedule to ensure the project stays on task (e.g. as traffic counts are completed, as existing simulations are optimized, as recommendations are projected, etc.)
- 4) a detailed plan of action as to how the timing plans will be implemented and field adjusted

The Consultant shall provide traffic signal timing information on two separate occasions: first, upon implementation and second, upon finalization of the contract. The data must include the direction of progression, cycle lengths, seconds per phase (splits), any variable phasing recommended, offsets, phase sequences, transition modes and limits, passage times, coordination modes, and time/space diagrams on hardcopy during the implementation phase and on USB device and hardcopy upon finalization of the contract.

All intersection clearance intervals (Yellow and All Red) shall be calculated based on most current KYTC standard of practice as defined in the KYTC Policy Manual.

All pedestrian clearance intervals shall be calculated based the newest recommendations in the latest official release of the Manual on Uniform Traffic Control Devices (MUTCD). Locations should be noted where splits fall below the calculated time required for proper pedestrian cycling.

Under no circumstances shall the minimum split time for phases (G+Y+R) be less than 12 seconds for any movement. Care should be taken to make certain that pedestrian movements would not allow for the skipping of any phases.

Efforts should be made to minimize cycle lengths whenever possible, with the cycle lengths based on even 10 second increments (e.g. 120, 130, 140, etc.). It is desired to have cycle lengths no longer than 180 seconds in normal instances.

Every effort should be made to eliminate intersection and turn lane spillback. Traffic should progress in such a manner that vehicles do not get stranded in any intersection during their clearance phase resulting in blocking traffic receiving a green indication during the next signal timing phase. Likewise, turning traffic should not queue past the beginning of turn bays blocking thru traffic in the adjacent thru lane.

The LFUCG is interested in the Consultant providing recommendations on variable phasing (Lead/Lead, Lead/Lag, Lag/Lead, Lag/Lag), resericing of phases, or any other non-conventional phasing on the mainlines as well as side streets (where applicable) so as to maximize progression bands and reduce travel times as much as possible while maintaining safety. The variable phasing can fluctuate throughout different times of day and days of week. Signalized intersections with Flashing Yellow Arrows (FYAs) can be reviewed in order to recommend left turn phasing operational changes (LFUCG/KYTC approval would need to be sought for the time of day disabling of phases prior to moving forward to final design). Volume and crash data may also be used to show where time of day left turn operational changes are needed (LFUCG/KYTC approval would need to be sought for the time of day left turn operational changes prior to moving forward to final design).

### **Implementation Specifics ...**

The Consultant shall be responsible (working with Division of Traffic Engineering staff) for the data entry, the implementation and the in-field adjustments and modifications of the timing plans for a period of time (not to exceed 2 hours per timing plan) so as to achieve

the most optimized plan(s). A remote connection may also be provided to one of LFUCG Traffic Engineering's computers via VPN connection. Each plan shall be field driven and adjusted by the Consultant with aid from the Division of Traffic Engineering staff if needed to achieve the most optimized plan. The consultant may also have access to LFUCG's traffic camera system to aid in the optimization of the timing plans.

### **Documentation of Improvements Specifics / Deliverables ...**

The Consultant shall gather travel time analytics related to travel times showing existing conditions upon Notice to Proceed under contract. The Travel time data surveys of conditions must include coverage of each of the eleven (11) timing plans. Following the implementation and adjustments to the new recommended timing plans, documentation during the same periods (i.e. same day of week and time of day) must be recorded and provided in the same manner to show improvements in travel conditions and shall match the final time/space diagrams submitted. If improvements are not shown graphically, an explanation must be written into the final hardcopy report defining the reasoning for the results. Note that earlier year's data may be incorporated due to the effect that the COVID-19 pandemic has had on traffic volumes and conditions in the past year.

\*\*The Consultant shall provide a detailed description as to the methodology used in defining the recommended traffic signal timing plans. The Consultant shall be Pre-Qualified with the KYTC in Traffic Engineering Services.

### **Provided information ...**

- 1) Current timing plan information (or access to this information via remote connection) for the project intersections will be provided to include the schedules of when existing timing plans go into effect, phase sequences, splits, cycle lengths and offsets, as well as current clearance and pedestrian timing.
- 2) Example tables of the expected new tables for Phases Sequence, Scheduler, Timing Plan Numbering Scheme, etc.
- 3) Copies of the MaxTime and MaxView User Manuals, which explains the MaxTime 2070 controller program and format and the MaxView traffic signal system software.
- 4) Staffing from the Division of Traffic Engineering will be available to assist in input of the recommended traffic signal timing plans from the Consultant into the PC-Based computerized traffic signal control system as needed.
- 5) Synchro 11 compatible base models for each route (and any other existing/current models for other TOD plans in operation)

- 6) Access to any travel time analytics that LFUCG may have available, such as INRIX data.

**Selection Criteria ...**

1. Specialized experienced and technical competence of the person or firm (including a joint venture or association) with the type of service required (20%)
2. Evaluation of the approach and methodology described in the submitted proposal (20%)
3. Familiarity with the details of this specific project (20%)
4. Capacity of the person or firm to perform the work, including any specialized services, within the time limitations (15%)
5. Past record and performance on contracts with the LFUCG or other governmental agencies and private industry with respect to such factors as control of cost, quality of work and ability to meet scheduling (15%)
6. Degree of local employment to be provided by the person or firm (10%)
