AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO PROVIDE FUNDS FOR PURCHASE ORDERS AND PRE-PAID EXPENSES ROLLING FROM FY 2020 INTO FY 2021, AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO 0003.
