EXTENSION OF AGREEMENT

THIS EXTENSION OF AGREEMENT (the "Extension"), dated as of September 30, 2022, (the "Effective Date"), by and between LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, an urban county government created pursuant to KRS Chapter 67A ("LFUCG"), located at 200 East Main Street, Lexington, Kentucky 40507, on behalf of its Department of Social Services, and UNIVERSITY OF KENTUCKY RESEARCH FOUNDATION ("UKRF"), whose main address is 109 Kinkead Hall, Lexington, Kentucky 40506-0057, (collectively known as the "Parties").

RECITALS

WHEREAS, the Parties entered into an Agreement on December 16, 2021 (the "Original Agreement"), for LFUCG to engage UKRF to complete the evaluation required by the First Responders and Community Partners Overdose Prevention Project grant (CFDA 92.243) by the Department for Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Prevention (Grant Number: 1H79SP08309-01); and

WHEREAS, the initial term of the Original Agreement was October 1, 2021 through September 30, 2022; and

WHEREAS, LFUCG was granted a one-time, no-cost extension of three (3) months to ensure completion of the originally approved project; and

WHEREAS, the Parties hereby agree to extend the term of the Original Agreement in accordance with the terms and conditions of the Original Agreement to reasonably complete the remaining work.

STATEMENT OF AGREEMENT

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein, the Parties agree to modify the Original Agreement as follows:

- 1. <u>Incorporation of Recitals</u>. The above recitals are incorporated herein as a part of this Extension.
- 2. Extension of Term. In accordance with Section 3(a) of the Original Agreement, the term of the Original Agreement is extended for an additional period of three (3) months, beginning September 30, 2022 and ending December 30, 2022 (the "Extension Term").
- 3. <u>Extension of Reporting Deadlines</u>. In accordance with Section 8 of the Original Agreement, UKRF's reporting deadlines shall be extended as follows:

- a. <u>Periodic Report</u>. To document the status of the project during the Extension Term, UKRF shall provide a quarterly report for the period of October 2022-December 2022, due by January 15, 2023.
- b. <u>Year-End Report</u>. UKRF shall furnish a final year-end report within 60 days of the end of the Extension Term, or by February 28, 2023.
- c. <u>Evaluation Summary</u>. UKRF shall provide an evaluation summary that includes all four years of grant activities by March 31, 2023.
- 4. <u>Effect</u>. All other provisions of the Original Agreement, which is attached hereto as "Exhibit A" and incorporated herein as if fully stated, not inconsistent with the provisions of this Extension shall remain in full force and effect.

IN WITNESS WHEREOF, the parties certify that they have been duly authorized to execute, deliver, and perform this Extension, and have executed the same as of the Effective Date written above.
