

RESOLUTION NO. 54 - 2016

A RESOLUTION CHANGING THE PROPERTY ADDRESS NUMBERS OF 414-414½ GRANARD AVENUE TO 414 GRANARD AVENUE, 416-416½ GRANARD AVENUE TO 416 GRANARD AVENUE, 418-418½ GRANARD AVENUE TO 418 GRANARD AVENUE, 5540 HURST LANE TO 5630 HURST LANE, 5600 HURST LANE TO 5550 HURST LANE, 1135 MONARCH STREET TO 1165 MONARCH STREET, AND 2590 PALUMBO DRIVE TO 2592 PALUMBO DRIVE AND CHANGING THE STREET NAMES AND PROPERTY ADDRESS NUMBERS OF 2625 CORNELIUS TRACE TO 3635 TRANQUILITY POINT, 4722 RHEMA WAY TO 4720 LARISSA LANE, 1302 RICHMOND ROAD, SUITE 40 TO 102 MCDOWELL ROAD, 1302 RICHMOND ROAD, SUITE 100 TO 100 MCDOWELL ROAD, SUITE 101, 1302 RICHMOND ROAD, SUITE 200 TO 100 MCDOWELL ROAD, SUITE 201, AND 1302 RICHMOND ROAD, SUITE 300 TO 100 MCDOWELL ROAD, SUITE 301 AND CHANGING THE NAME OF MILANO ROAD FROM ITS INTERSECTION WITH CENTRE PARKWAY NORTHEAST TO ITS TERMINUS TO CAMPUS WAY AND CHANGING THE NAME OF WOODHILL DRIVE FROM ITS INTERSECTION WITH EAST NEW CIRCLE ROAD WEST TO ITS TERMINUS TO LIFE LANE, ALL EFFECTIVE THIRTY DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the property address numbers of the following properties be and hereby are changed as follows:

(a) Granard Avenue:

<u>Current</u>	<u>New</u>
414-414 ½ Granard Avenue	414 Granard Avenue
416-416 ½ Granard Avenue	416 Granard Avenue
418-418 ½ Granard Avenue	418 Granard Avenue

(b) Hurst Lane:

<u>Current</u>	<u>New</u>
5540 Hurst Lane	5630 Hurst Lane
5600 Hurst Lane	5550 Hurst Lane

(c) Monarch Street:

<u>Current</u>	<u>New</u>
1135 Monarch Street	1165 Monarch Street

(d) Palumbo Drive:

<u>Current</u>	<u>New</u>
2590 Palumbo Drive	2592 Palumbo Drive

Section 2 – That the street names and property address numbers of the following properties be and hereby are changed as follows:

- (a) Cornelius Trace: That the name of Cornelius Trace located at 2625 is changed to Tranquility Point and the following number changes are made:

<u>Current</u>	<u>New</u>
2625 Cornelius Trace	3635 Tranquility Point

- (b) Rhema Way: That the name of Rhema Way located at 4722 is changed to Larissa Lane and the following number changes are made:

<u>Current</u>	<u>New</u>
4722 Rhema Way	4720 Larissa Lane

- (c) Richmond Road: That the name of Richmond Road located at 1302 is changed to McDowell Road and the following number changes are made:

<u>Current</u>	<u>New</u>
1302 Richmond Road, Suite 40	102 McDowell Road
1302 Richmond Road, Suite 100	100 McDowell Road, Suite 101
1302 Richmond Road, Suite 200	100 McDowell Road, Suite 201
1302 Richmond Road, Suite 300	100 McDowell Road , Suite 301


Section 3 – That the street name of the following be and hereby are changed as follows:

- (a) Milano Road: That the name of Milano Road from its intersection with Centre Parkway northeast to its terminus is changed to Campus Way.
- (b) Woodhill Drive: That the name of Woodhill Drive from its intersection with East New Circle Road west to its terminus is changed to Life Lane.


Section 4 - That this Resolution shall be effective thirty (30) days from passage.
