I officially forwarded the attached agreement for review by Law prior to Legistar. I am sending the cost information contained in the MOA as FYI.

COST: All recruits will be enrolled at the current approved in-state tuition rate. Police will make one lump sum payment to BCTC for the total tuition, fees and charges due based upon the number of credit hours enrolled, payable on or before the 60th day following the beginning of each term/semester/cohort. This is based on the current tuition and fees as referenced at: http://www.bluegrass.kctcs.edu/en/Costs and Financial Aid/Tuition and Fees.aspx. This rate is for a minimum of ten students per section for each cohort/group. Any cohort less than 10 will require additional payment to achieve the minimum enrollment of 10. The Police or participants will be responsible for the purchase of books and class materials.
