-) \$1,177.21 to the Unappropriated Fund Balance in the Water Quality Management Fund from various accounts.
-) \$45,393.22 to the Unappropriated Fund Balance in the Landfill Fund from various accounts.
-) \$126,043.50 to the Unappropriated Fund Balance in the Medical Insurance Fund from various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0006", attached hereto and incorporated herein by reference.
