AGREEMENT

Agreement between The University of North Florida Training and Service Institute, Inc., d/b/a the Institute of Police Technology and Management, Jacksonville, Lexington-Fayette Urban County Government, Lexington, Kentucky,

FOR

Providing professional, technical and other services needed in conducting a twenty-four (24) hour training course entitled "*Burglary Investigations*" for a maximum of forty (40) students.

It is agreed that the Institute of Police Technology and Management will provide the following at Lexington:

1. One instructional program in "Burglary Investigations"
2. To commence on January 14, 2013 and conclude on January 16, 2013.
3. Instructional materials prepared at the Institute of Police Technology and Management.
4. Trainee materials prepared for dissemination during the course.
5. An appropriate Certificate of Completion for each trainee satisfactorily completing the course.
6. Technical assistance required to prepare, conduct and evaluate the course.
7. Training aids and student reference materials.
8. Making all arrangements for obtaining instructors, preparation of the instructor activities and all other arrangements pertaining to instructor transportation and honoraria.

The Lexington-Fayette Urban County Government agrees to pay a total sum of eleven thousand five hundred dollars (\$11,500) to the Institute of Police Technology and Management for conducting this course for a maximum of forty (40) students. Course may be cancelled 30 days prior to start date with no penalty. A 10% cancellation fee will be charged any time thereafter.

It is further agreed that the Lexington-Fayette Urban County Government will provide classroom facilities and have available the following audio-visual equipment:

1. Chalk Board/White Board
2. LCD-PowerPoint Projector and Screen
3. Easel to hold pads of flip chart paper
4. Cart with: TV, VCR and DVD decks (or combination deck)
