SECOND AMENDMENT TO MEMORANDUM OF AGREEMENT

THIS SECOND AMENDMENT TO MEMORANDUM OF AGREEMENT (the "Amendment"), dated as of Color of the Color of the Commonwealth of the Commonwealth of Kentucky created pursuant to KRS Chapter 67A (the "LFUCG"), located at 200 East Main Street, Lexington, Kentucky 40507, and GOODWILL INDUSTRIES OF KENTUCKY, INC. D/B/A GOODWILL KENTUCKY ("Organization"), whose post office address is 2820 West Broadway, Louisville, Kentucky 40211 (collectively known as the "Parties").

RECITALS

WHEREAS, the LFUCG entered into a Memorandum of Agreement, executed on April 23, 2024 (the "Agreement"), to provide funds to Organization to fulfill a public purpose in helping the most vulnerable residents of Lexington, homeless families with children, find long-term housing stability; and

WHEREAS, the Parties entered into a First Amendment to the Memorandum of Agreement (pursuant to Resolution 077-2025) wherein the initial term of the Agreement was extended to December 31, 2025 and the scope of services was revised to include a full-time Career Coach; and

WHEREAS, the parties desire to amend the Agreement, as previously amended, to extend the term of the Agreement to now end on December 31, 2026; and

WHEREAS, the Parties hereby agree to amend the above-referenced term in accordance with the terms and conditions of this Amendment.

STATEMENT OF AGREEMENT

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein, the Parties agree to modify the Agreement as follows:

- 1. <u>Incorporation of Recitals</u>. The above recitals and referenced exhibits are incorporated herein as a part of this Amendment.
- 2. <u>Section 1. Effective Date; Term.</u> The Parties agree to modify Section 1 of the Agreement to extend the period of performance to December 31, 2026 as follows:
 - "This Agreement shall commence on April 1, 2024, and shall last until December 31, 2026, unless terminated by LFUCG at an earlier time."
- 3. <u>Effect</u>. All other provisions of the Agreement, as previously amended, which are not inconsistent with the provisions of this Amendment shall remain in full force and effect.
