## PURCHASE OF SERVICE AGREEMENT

THIS PURCHASE OF SERVICE AGREEMENT (hereinafter "Agreement"), made and entered into on the \_\_\_\_th day of August, 2022, by and between the LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, an urban county government of the Commonwealth of Kentucky created pursuant to KRS chapter 67A (hereinafter "Government"), 200 East Main Street, Lexington, Kentucky 40507, on behalf of its Department of Social Services (hereinafter "Sponsor"), and, the MISSION LEXINGTON, INC. DBA MISSION HEALTH LEXINGTON with offices located 230 S. Martin Luther King Boulevard, Lexington, KY 40508, (hereinafter "Organization").

## WITNESSETH

That for and in consideration of the mutual promises and covenants herein expressed, the Government and the Organization agree as follows:

- This Agreement shall include the following additional documents, which are attached hereto as exhibits and incorporated herein by reference as if fully stated:
  - A. Exhibit A RFP # -2022
  - B. Exhibit B Organization's Response to RFP # -2022
- 2. Government hereby retains Organization for the period beginning on **July 1**, **2022**, and continuing for a period of two (2) years from that date unless within that period Government gives the Organization thirty (30) days written notice of termination of this Agreement in which case this Agreement shall terminate thirty (30) days from the date notice is given to the Organization.
- 3. Government shall pay Organization the sum of Forty-Six Thousand and Five Hundred and 00/100 Dollars (\$46,500) for Fiscal Year 2023 and Forty-Six Thousand and Five Hundred and 00/100 Dollars (\$46,500) for Fiscal Year 2024 for the services required

by this Agreement, said services being more particularly described in Exhibits A and B, one-fourth (1/4<sup>th</sup>) of which shall be payable in September 2022 or shortly thereafter upon receipt of an **invoice** (for July through December 2022), with one-eighth (1/8<sup>th</sup>) payable each quarter thereafter upon submission of a quarterly invoice and a detailed quarterly program report. Quarterly invoices and detailed program reports shall be submitted by January 20<sup>th</sup>, 2023, April 21<sup>st</sup>, 2023, July 24<sup>th</sup>, 2023, October 20<sup>th</sup>, 2023, January 26<sup>th</sup>, 2024, and April 19<sup>th</sup>, 2024. A two-year-end program report shall be submitted by July 19<sup>th</sup>, 2024. Reports shall reflect the services and programs directly related to the funding provided by Lexington Fayette Urban County Government with emphasis on measurable outcomes, and specifically outlined in the funding application. Forms for both the quarterly financial and program reports will be provided.

- 4. In the event of termination of this Agreement by Government as provided for in paragraph 1 above, Organization shall be entitled to that portion of total compensation due under this Agreement as the service rendered bears to the service required herein.
- 5. Organization shall perform all duties and services included in Exhibits attached hereto faithfully and satisfactorily at the time, place and for the duration prescribed herein. Compensation paid pursuant to this Agreement shall be used exclusively for the services set forth in Exhibits A and Band for no other purpose. Any alteration in the nature of such services and duties constitutes an amendment to this Agreement and must be in writing signed by both parties. Organization shall keep itself fully informed of all federal and state laws and all municipal ordinances and regulations in any manner affecting the work or performance of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein, and
- 6. Organization shall indemnify, defend and hold harmless Government, its elected and appointed officials, employees, agents, volunteers, and successors in interest,

from and against any and all liability, damages, and losses, including but not limited to: demands, claims, liens, suits, notices of violation from governmental agencies, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees that are in any way incidental to or connected with, or that arise or are alleged to have arisen, directly or indirectly, from or by Organization's performance of or breach of this Agreement and/or the provision of goods or services, provided that (a) it is attributable to personal injury, bodily injury, sickness, or death, or to injury to or destruction of property (including the loss of use resulting therefrom), or to or from the negligent acts, errors or omissions or willful misconduct of the Organization; and (b) not caused solely by willful misconduct of the Government. The Parties understand and agree that the Organization's obligation to defend the Government includes the obligation to investigate, handle, respond to, resist, provide a defense for, and defend claims, at Organization's expense, using attorneys approved in writing by the Government, which approval shall not be unreasonably withheld. The Parties also understand and agree that the Organization's obligation to indemnify includes, but is not limited to: attorney fees and expenses, costs of litigation, court and administrative costs, expert witness fees and expenses, judgments, fines, penalties, interest, all environmental cleanups and remediation costs of whatever kind, and any liability arising from death, injury, or damage of any kind, to any person, including employees and agents of Organization and Government, and damage to, or destruction of, any property, including the property of Government. This provision shall in no way be limited by any financial responsibility or insurance requirements, and shall survive the termination of this Agreement. Organization understands that Government is a political subdivision of the Commonwealth of Kentucky and acknowledges and agrees that the Government is unable to provide indemnity or otherwise save, hold harmless, or defend the Organization in any manner.

- 7. Organization represents that it has filed all federal, state and local income tax returns required by law in the legally prescribed time and manner. This Agreement shall not become effective unless and until copies of all of the executed originals of the aforementioned tax returns filed for the Organization have been registered for the current tax year by the Organization in the office of the Sponsor, and the Organization shall not be compensated unless and until such registration has taken place.
- 8. The Organization shall, on such forms as the Sponsor shall provide, submit to Sponsor an annual report and financial statement which summarize the previous year's activities regarding the services enumerated in Exhibits A and B attached hereto.
- 9. Books of accounts shall be kept by the Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of the Organization. The books of accounts, together with all bonds, notes, bills, letters and other writings belonging to the Organization, shall be maintained at the principal place of business of the Organization as set forth in this Agreement. Government shall have free and complete access to the books, papers and affairs of the Organization, that relate to the performance of this Agreement, at all reasonable times, and if it desires, it may have the books and papers of the Organization, that relate to the performance of this Agreement, audited and examined by auditors, accountants or attorneys. Any examination shall be at the expense of the Government.
- 10. Government may designate such persons as may be necessary to monitor and evaluate the services rendered by the Organization. The Government, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and monitoring of the work by these authorities shall in no manner be presumed to relieve in any degree the

responsibility or obligations of Organization, nor to constitute the Organization as an agent of the Government.

- 11. Organization shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and shall cause each of its subcontracting agencies to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.
- 12. Organization shall adopt a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be submitted to Sponsor for review within thirty (30) days of the execution of this Agreement.
- 13. This instrument, and additional documents attached hereto, contains the entire agreement between the parties, and no statement, promises or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid and binding; and this Agreement may not be enlarged, modified or altered except in writing signed by the parties and endorsed hereon.
- 14. Organization agrees that it shall apply all funds received by it from the Urban County Government in accordance with the following investment policy guidelines:
  - A. Objectives: Capital preservation with surety of income. Reasonable competitive income consistent with high investment quality and purpose of funds. All investments shall conform with state and local law and regulations and these policies.
  - B. Investment Funds Management: The governing board may elect to either:

- (1) Manage its investment through its executive director where the size or complexity of funds to be managed is deemed by the board to be within the training, expertise and/or available time capacity of the executive director and the operating staff; or
- (2) Utilize the professional investment management facilities of a local bank trust department acting in a fiduciary capacity within the same approved investment policies and federal, state, local and trust laws and regulation. The trust department may utilize its regular short-term one hundred percent (100%) US Treasury Fund for daily funds investment.

The election of option 1 or 2 should be made consistent with the relative cost incurred and in the case of option 2 the cost shall be competitive among local trust departments.

- C. Investment Policies - Safety and Prudence.
  - (1) Short-term liquidity funds shall be invested in "riskless" investment, i.e., deposits in Kentucky commercial banks or savings and loan associations that are fully federally insured or deposits collateralized by U.S. Treasury securities with a current market value of at least one hundred percent (100%), or in direct obligations of U.S. Treasury securities.

Investments shall be diversified according to maturity in order to meet projected cash flow needs.

Collateral pledged to secure uninsured deposits shall be held at a federal reserve bank with the receipt providing absolute control by the agency.

- (2) Retirement funds, endowment funds, long-term capital reserve funds and any other special funds may be held and invested by a local bank trust department under investment objectives and diversification in accordance with the individual nature of the funds and pursuant to the "prudent man" investment rule as well as general trust law.
- (3) All investments shall be reviewed monthly by a finance or investment committee of the agency.
- (4) Local brokerage firms may hold and invest funds provided that investments are located within Kentucky and are full insured.
- D. Audit - All investments shall be audited at least annually by independent certified public accountant who shall express an opinion as to whether or not investments during the year audited have conformed with state and local law and regulation and with the approved investment policies.

## 5.1 Program Proposal & Design

## 5.1.1 Needs Statement—Purpose of the Program Proposal / Problem Statement

The Cabinet for Health and Family Services reports that 13.3% of adults in Kentucky had diabetes in 2019 - nearly doubling since their last report in 2000. 11% have pre-diabetes. Centers for Disease Control and Prevention reports that 8.5% of Fayette County adults have diabetes. The American Association of Diabetes states that "depression and other mental health related conditions are more commonly found in people with diabetes. In the U.S. 17.9% of the population is affected by a mental illness; however, for people with diabetes this is often greater and can have a serious impact on diabetes management." The Foundation for a Healthy Kentucky reports that 10% of Fayette County adults (18-64) are uninsured. The high costs associated with mental health care and diabetes management causes clients to delay the care they need because of the financial burden that healthcare can be to individuals and families living on low and no incomes.

The Diabetes Project at Mission Health Lexington weaves together mental healthcare, primary medical care, dental care, vision care, prescription assistance, and diabetes case management into one program specifically targeting adult residents of Fayette County who are living without insurance and below federal poverty guidelines. Our clients face financial, transportation, and language obstacles when accessing healthcare because they are uninsured, living in poverty, and often times ineligible for government funded assistance. By having all components together in one facility, we further remove barriers for our clients. We serve our most vulnerable neighbors in need who are experiencing gaps in access to services, many of whom are homeless or are at risk of homelessness.

## 5.1.2 Service Delivery Model

Mission Health Lexington has a volunteer psychiatrist who holds a monthly clinic providing therapy and medication management; medical providers who treat mental health issues like depression and anxiety in conjunction with other health conditions like diabetes; an on-site lab for comprehensive panels, and an on-site pharmacy for clients to fill prescriptions. Free comprehensive healthcare services, including free medication and therapy, for impoverished and uninsured populations is rare. The Diabetes Project provides services specific to diabetic clients to assist them in achieving goals without the financial burden or expenses associated with therapy, medication management, diabetes case management, labs, and office visits with providers. Activities include counseling, individual diabetes case management, medication management, prescription filling, and routine labs. Additionally, patients have access to dental and vision services. Mission Health Lexington allows healthcare to be accessible.

Units of service vary by client as each client's needs are specific to their treatment plan. Examples include:

- > monthly medication management session with a provider
- > one 30-minute general health exam with blood work done monthly, quarterly, semi-annually, or annually as determined by a medical professional
- > 30-60 minute session with Diabetes Project Nurse Practitioner and Diabetes Project Case Manager occurring weekly, bi-weekly, or monthly
- > monthly 10-minute medication management session with a provider

## 5.1.3 Client Eligibility and Requirements

Current eligibility requirements for services at Mission Health Lexington are as follows:

- > Client must be a resident of Fayette County, Kentucky
- > Client must be 18 years of age or older
- > Client must be living at, or below, 185% of federal poverty guidelines
- > Clients must be uninsured

Mission Health Lexington does not charge for services rendered.

Clients are expected to maintain appointments, or call if they are unable to make a scheduled appointment. If a client has three consecutive missed appointments where they did not call in advance to notify staff they are placed on a six-month probation period and are provided appropriate referrals to outside clinics if needed. After the six-month probation period is over clients are able to schedule appointments again. No other requirements remain for participation in services.

## 5.1.4 Evidence-Based/Best Practice

The Diabetes Project is based on the Chronic Care Model featuring the following six components: Delivery System Design, Self-Management Support, Clinical Information Systems, Decision Support, Community, and Health Systems.

We integrate the six components in the following way:

- 1) Our delivery system design is team-based client care with psychiatrists, physicians, pharmacists, and case managers all working together with the client to address their care plan comprehensively.
- 2) Our self-management support utilizes all of the team members to provide clients with the knowledge and strategies they need to confidently manage their care.
- 3) Our clinical information system is our electronic medical records program where all members of the care team document care and resources so everyone is able to stay aware of the client's progress and identify any potential gaps in the care plan.
- 4) Our decision support component is goal planning (like a client progress report) where we encourage clients to to participate in their care plan through the different care components offered.
- 5) Our community component is our ability to refer patients to outside resources to fill any gaps in their care.
- 6) Our health systems component is the overall program goal of promoting effective care by utilizing a team-based approach.

## 5.2.1 Service Efficacy & Desired Outcomes

Below are examples of Diabetes Project client achievements and goal examples for each particular achievement:

1 - Achievement: Decrease depressive symptoms

Goal: Client will track depressive symptoms and report them to provider to monitor

2 - Achievement: Adopt self-care methods when depression and anxiety symptoms increase

Goal: Client utilizes personalized self-care methods to decrease symptoms

3 - Achievement: Attend scheduled appointments at Mission Health Lexington

Goal: Client attends scheduled appointments and if unable to attend will cancel in appropriate time frame

4 - Achievement: Full understanding and adherence to medications

Goal: Client takes medications as prescribed and works with providers to understand medications through training

5 - Achievement: Improved labs and vitals (A1C, cholesterol, blood pressure, weight)

Goal: Client attends appointments and implements lifestyle changes including exercise, food choices, medication adherence

Each client is unique, so our service philosophy is meeting the client where they are. Successful completion of services is subjective and unique to each client. There is no ending to services. As long as clients continue to qualify for services then they can continue as their healthcare provider sees necessary. Examples: completing appointments, picking up prescriptions, taking medication as prescribed, working on personal relationships, applying for jobs that include insurance benefits, completing medical exams. As of today, all clients in the Diabetes Project have completed at least one achievement, even if it is as simple as arriving as scheduled for appointments.

## **5.2.2 Client Empowerment & Community Impact**

Access to mental health and medical services saves lives and opens doors for the under-served in our community. Improved mental health can enhance the productivity and economic viability of the clients served. Value is added to the community through increased independence, stability, and growth. Clients see improved relationships, changes in attitude and behavior, and the ability to cope and manage everyday stresses like diabetic care. Clients are be empowered and motivated leading to improved employment, education, and housing opportunities.

Last week we had a patient come in for an appointment with his primary care physician. He let us know that he had found a job as a postal worker and now has insurance benefits and wanted help transferring his medical records to a new doctor and prescriptions to a new pharmacy. In the short time that he has been delivering mail he has already lost 8lbs from the walking. He reported that he was feeling great and shared feelings of optimism and hope. When he was unemployed and barely able to pay rent he was able to access comprehensive care at Mission Health Lexington. He didn't have to worry about being able to afford his prescriptions or having to skip appointments because he couldn't afford the visits. By being able to save his resources for rent, utilities, and groceries he was able to stay housed while he looked for a new job. This is just one example of the meaningful difference Mission Health Lexington services make in the lives of those we serve.

We also have been able to hire multiple bilingual employees in the last year allowing us to have translation services available to all services are accessible to more of our neighbors in need providing a safe and welcoming environment to all who feel they have nowhere else to turn.

## 5.2.3 Data Assessment & Quality Improvement

Evaluating the effectiveness of our services varies with each unique client and their specific treatment plans. We utilize a variety of tools including the PHQ and GAD7, lab results, client satisfaction surveys, and overall goal achievement. Symptom checklists are completed regularly to evaluate the effectiveness of the treatment plan. Participants in the Diabetes Project have lab work completed every three months. Individualized report cards are utilized to evaluate overall goal achievement. These are updated at each case management session. The tools we use are directly in-line with the desired outcomes of our clients.

## Examples:

- If a client and provider agree that a lowered A1C is critical and after their baseline labs they have lowered their A1C then that desired outcome has been met.
- If a client scores a 15 on their GAD7 at their first appointment, works with the psychiatrist to better control their anxiety, and then scores a 10 a few months later than the decreased symptoms indicate the desired outcome has been met.

Every client is expected to participate in the evaluation process that best suits their individual care plan. This information is vital as we continue to grow and improve the program and continue to tailor their care specific to their individual needs. Additionally, feedback will help us adjust and expand service offerings and continue to fill gaps in care identified in the different assessment tools.

Program results are reviewed every six months.

- Susan Maupin: Serves as the Diabetes Project Case Manager working in collaboration with the Nurse Practitioner to meet with patients individually and manage patient care plans and program materials.
- DeShayna Davis, APRN: Serves as the Diabetes Project Nurse Practitioner working in collaboration with the Case Manager to meet with patients individually and manage patient care.
- Mary Cowles, MD: Psychiatrist, providing and overseeing all psychiatric services including therapy and medication management.
- Matt McMahan, PharmD: Pharmacist in Charge, overseeing all pharmacy operations.
- John Miller, MD: Medical Clinic Director, overseeing all Medical Clinic operations and serving as physician with special focus on internal medicine and diabetic care.
- Lon Keith, MD: serves as physician with special focus on internal medicine and diabetic care.
- Phillip Hoffman, MD: serves as physician with special focus on internal medicine and diabetic care.

## 5.3.2 Partnership & Resource Leverage

Mission Health Lexington's comprehensive programs and services support LFUCG's priority focus of Mental Health & Community Wellness and Safety by providing medical and pharmaceutical services to Fayette County residents living without insurance, below federal poverty guidelines, and who are experiencing mental health symptoms that are affecting their overall health and wellness, ability to work and make community contributions, and overall emotional, physical, and social stability. Services are provided free of charge by volunteer licensed healthcare professionals. Many members of our Board of Directors are healthcare professionals who are past or active volunteers in our clinics. Each clinic has a Volunteer Director who works directly with staff to ensure programs are executed effectively and efficiently having the greatest impact. When Mission Health Lexington is unable to provide a service we provide referrals to local service providers like Surgery on Sunday, University of Kentucky, and Kentucky Cancer Link for specific medical needs. For social services we provide referrals to Maxwell Street Presbyterian Church Emergency Assistance Program. For food pantry needs we refer to God's Pantry.

Funding support comes from a variety of sources. Our work countermands the systematic inequities that individuals in our community face everyday. We provide health and healing to our neighbors in need by providing access to free healthcare. We work to remove the barriers our clients face accessing the lifesaving care they need and deserve. The work of our clinic is directly in-line with the Mayor's Commission on Racial Justice and Equality Health Disparities Sub-Committee Recommendations. We work to build trust with each and every client with a diverse team of healthcare providers who provide culturally competent care. Our clients are our biggest source of outreach. Many of our clients live in close-knit communities and in multi-generational homes. They share details of our clinics within their communities. We work with partners (social services, churches, etc.) who provide direct referrals, feature our services in resources at their facilities, etc.

Our services are available to Fayette County residents who are living without insurance and below federal poverty guidelines. We are located at 230 S. Martin Luther King Blvd, Lexington, KY 40508, a single-level wheelchair accessible facility that is 0.1 mile from the City of Lexington Transit Center. We utilize multi-language forms and have staff on-site to provide assistance for patients who are unable to read/write. We have interpreters to assist with Spanish translation needs and utilize a telephone based medical interpreter that has 225 languages available. Clinics are offered Monday through Thursday and Saturday with hours varying (daytime, evening, weekends) to provide optimal accessibility. We also have bus passes available for clients with transportation barriers.

## Laws and Regulations

All applicable state laws, municipal ordinances and regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

## **Equal Employment Opportunity**

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and to promote equal employment through a positive, continuing program from itself and each of its subcontracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

## Kentucky Equal Employment Opportunity Act

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

## The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

- (1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.
- (2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

- (1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.
- (2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the

contractor complies in full with the requirements of KRS 45.560 to 45.640.

(3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as <a href="mailto:special-conditions">special-conditions</a> in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available workforce in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

## **LFUCG Non-Appropriation Clause**

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

## **GENERAL PROVISIONS**

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

- 5. Liability: LFUCG is not responsible for any cost incurred by a Respondent in the preparation of proposals.
- 6. Changes/Alterations: Respondent may change or withdraw a proposal at any time prior to the opening; however, no oral modifications will be allowed. Only letters, or other formal written requests for modifications or corrections of a previously submitted proposal which is addressed in the same manner as the proposal, and received by LFUCG prior to the scheduled closing time for receipt of proposals, will be accepted. The proposal, when opened, will then be corrected in accordance with such written request(s), provided that the written request is contained in a sealed envelope which is plainly marked "modifications of proposal".
- 7. Clarification of Submittal: LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
- Bribery Clause: By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted

to bribe an officer or employee of the LFUCG.

- 9. Additional Information: While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal,
- 10. Ambiguity, Conflict or other Errors in RFP: If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
- 11. Agreement to RFP Terms: In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract/Grant under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
- 12. Cancellation: If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the cancellation if such action is in its best interest.

## A. Termination for Cause

- LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties

  - (e) The filing of a bankruptcy petition by or against the contractor; or
  - (f) Actions that endanger the health, safely or welfare of the LFUCG or its citizens.

## B. At Will Termination

Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent, Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

- 13. Assignment of Contract: The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. Any purported assignment or subcontract in violation hereof shall be void. It is expressly acknowledged that LFUCG shall never be required or obligated to consent to any request for assignment or subcontract; and further that such refusal to consent can be for any or no reason, fully within the sole discretion of LFUCG.
- 14. No Waiver: No failure or delay by LFUCG in exercising any right, remedy, power or privilege hereunder, nor any single or partial exercise thereof, nor the exercise of any other right, remedy, power or privilege shall operate as a waiver hereof or thereof. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
- 15. Authority to do Business: The Respondent must be a duly organized and

authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. The Respondent will provide LFUCG with a copy of a corporate resolution authorizing this action and a letter from an attorney confirming that the proposer is authorized to do business in the State of Kentucky if requested. All proposals must be signed by a duly authorized officer, agent or employee of the Respondent.

- 16. Governing Law: This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. In the event of any proceedings regarding this Contract, the Parties agree that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division. All parties expressly consent to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to this Contract or any rights or obligations arising thereunder. Service of process may be accomplished by following the procedures prescribed by law.
- Ability to Meet Obligations: Respondent affirmatively states that there are no actions, suits or proceedings of any kind pending against Respondent or, to the knowledge of the Respondent, threatened against the Respondent before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of Respondent to perform its obligations under this Contract, or which question the legality, validity or enforceability hereof or thereof.
- 18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
- 19. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.

## 1.0 GENERAL INFORMATION & SCOPE

## 1.1 Background

Each fiscal year the Mayor and Urban County Council allocate funds for use by selected 501(c)(3) non-profit partner agencies through the Department of Social Services' Extended Social Resource (ESR) Program.

This grant cycle shall cover Fiscal Years 2023 and 2024 (July 1, 2022 – June 30, 2024), and will award grants between the four Funding Priorities, which each have separate required Proposal Submittals and criteria, and awarded on an approximate scale, listed below.

## **Funding Priority Area: Community Wellness & Safety**

Projected funding is approximately \$900,000 of total ESR Grant Program Community Based Initiatives Award. This amount is subject to change upon Council ratification of the Fiscal Year 2023 Budget.

LFUCG seeks to strengthen and enhance Community Wellness and Safety, by supporting programs and services addressing *Mental Health, Substance Misuse Disorder, and Community Violence Intervention.* LFUCG intends to award grants for priority-rated programs and services which originate with demonstrated client needs, establish clearly-defined outcomes, and are designed to best practices or evidence-based models.

## 2.0 GENERAL PROVISIONS

## 2.1 Purpose

The LFUCG is accepting applications from qualified non-governmental, non-profit agencies with current **501(c)3** tax exempt status and with a physical business or program site location in Fayette County (hereinafter, referred to as "Applicant") for ESR funding for FY2023 & 2024 (July 1, 2022 – June 30, 2024). This funding is intended to support agency **programs** which respond to the **funding priorities** established herein. **THIS FUNDING IS <u>NOT</u> INTENDED TO SUPPORT GENERAL AGENCY OPERATIONS, other than overhead required to support the subject program.** 

## 2.2 Funding Period

The funding period is from July 1, 2022 through June 30, 2024.

## 2.3 **ESR Grant Informational Workshop**

The Department of Social Services conducted a meeting on January 20<sup>th</sup>, 2022 that provided potential proposers with an overview of the proposal and review process, instructions on completing the RFP, and presentation of funding priorities.

## 2.4 **Proposal Submission**

Significant missing responses to questions constitute an incomplete application. The final decision regarding application completeness and penalties will be determined by the LFUCG Division of Central Purchasing in consultation with the Commissioner of Social Services. ## **Funding Priority Area: Community Wellness & Safety**

Projected funding is \$900,000 of ESR Grant Program – Community Based Initiatives

LFUCG seeks to strengthen and enhance Community Wellness and Safety, by supporting programs and services addressing *Mental Health, Substance Misuse Disorder, and Community Violence Prevention.* LFUCG intends to award grants for priority-rated programs and services which originate with demonstrated client needs, establish clearly-defined outcomes, and are designed to best practices or evidence-based models. These programs may address one or more of the following areas, but shall not be limited to:

- Substance Misuse Disorder, which include prevention of alcohol and drug abuse; prevention and treatment of addictive and mental disorders through programs and services for individuals who suffer from these disorders; and harm reduction.
- Mental Health, which is defined as a state of well-being in which every individual realizes his or her own
  potential, can cope with the normal stresses of life, can work productively and fruitfully, and is able to
  make a contribution to her or his community. Mental health includes our emotional, psychological, and
  social well-being. It affects how we think, feel, and act. It also helps determine how we handle stress,
  relate to others, and make choices. Mental health is important at every stage of life, from childhood
  and adolescence through adulthood.
- Community Violence Prevention, which includes Youth Violence Intervention, including Gang & Gun Violence, Child Abuse & Neglect Services, Sexual Violence Prevention, Elder Abuse Prevention, Suicide Prevention and Intimate Partner Violence Prevention and Stalking.

The term "client" is used throughout this proposal; however we understand that within the context of your work "client" may not mean an individual. For some agencies it may be helpful to think of "client" as whole system (such as a school) or as a neighborhood, group, or community.

What role does your governing board members, volunteers, and / or donors play in facilitating viable service delivery and program administration? Does your program have any major civic benefactors or corporate sponsors? Describe other secured funding sources and committed operational resources your organization has allocated for the proposed program.

### 5.3.3 Outreach & Inclusion Strategy

15 Points

Demonstrate how the program will ensure services are available and accessible by all potential participants, especially related to language barriers for persons with limited English proficiency; persons with physical or other disabilities; and persons impacted by poverty and economic distress.

Has your organization enacted any policies (or employs any standard operating procedures) to ensure equitable service opportunity and / or benefit program to a diverse cross-section of the greater community? How does your proposal support or enhance the recommendations made by the Mayor's Commission on Racial Justice & Equality?

## **6.0 Program Budget Summary Form**

Proposal Submittal shall be considered incomplete and shall be rejected without completed Budget Summary Form. (Including total amount of FY23 ESR grant request.)

<u>Budget Form will be for Fiscal Year 2023 ESR Request only. Funds awarded for Fiscal Year 2024</u> <u>shall be the same amount as awarded for Fiscal Year 2023</u>, and contingent on Council approval of the Fiscal Year 2024 budget.
