#### PURCHASE OF SERVICE AGREEMENT

THIS PURCHASE OF SERVICE AGREEMENT (hereinafter "Agreement"), made and entered into on the \_\_\_\_<sup>th</sup> day of August, 2022, by and between the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government of the Commonwealth of Kentucky created pursuant to KRS chapter 67A (hereinafter "Government"), 200 East Main Street, Lexington, Kentucky 40507, on behalf of its Department of Social Services (hereinafter "Sponsor"), and **THE REFUGE CLINIC** with offices located 2349 Richmond Road Suite 220 Lexington, KY 40502, (hereinafter "Organization").

#### <u>WITNESSETH</u>

That for and in consideration of the mutual promises and covenants herein expressed, the Government and the Organization agree as follows:

- This Agreement shall include the following additional documents, which are attached hereto as exhibits and incorporated herein by reference as if fully stated:
  - A. Exhibit A RFP # -2022
  - B. Exhibit B Organization's Response to RFP # -2022

2. Government hereby retains Organization for the period beginning on **July 1**, **2022**, and continuing for a period of two (2) years from that date unless within that period Government gives the Organization thirty (30) days written notice of termination of this Agreement in which case this Agreement shall terminate thirty (30) days from the date notice is given to the Organization.

3. Government shall pay Organization the sum of **One Hundred and Fifteen 00/100 Dollars (\$115,000)** for Fiscal Year 2023 and **One Hundred and Fifteen and 00/100 Dollars (\$115,000)** for Fiscal Year 2024 for the services required by this Agreement, said services being more particularly described in Exhibits A and B, one-fourth (1/4<sup>th</sup>) of which shall be payable in September 2022 or shortly thereafter upon receipt of an **invoice** (for July through December 2022), with one-eighth (1/8<sup>th</sup>) payable each quarter thereafter upon submission of a quarterly invoice and a detailed quarterly program report. **Quarterly invoices and detailed program reports shall be submitted by January 20<sup>th</sup>, 2023, April 21<sup>st</sup>, 2023, July 24<sup>th</sup>, 2023, October 20<sup>th</sup>, 2023, January 26<sup>th</sup>, 2024, and April 19<sup>th</sup>, 2024. A two-year-end program report shall be submitted by July 19<sup>th</sup>, 2024. Reports shall reflect the services and programs directly related to the funding provided by Lexington Fayette Urban County Government with emphasis on measurable outcomes, and specifically outlined in the funding application. Forms for both the quarterly financial and program reports will be provided.** 

4. In the event of termination of this Agreement by Government as provided for in paragraph 1 above, Organization shall be entitled to that portion of total compensation due under this Agreement as the service rendered bears to the service required herein.

5. Organization shall perform all duties and services included in Exhibits attached hereto faithfully and satisfactorily at the time, place and for the duration prescribed herein. Compensation paid pursuant to this Agreement shall be used exclusively for the services set forth in Exhibits A and Band for no other purpose. Any alteration in the nature of such services and duties constitutes an amendment to this Agreement and must be in writing signed by both parties. Organization shall keep itself fully informed of all federal and state laws and all municipal ordinances and regulations in any manner affecting the work or performance of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein, and

6. Organization shall indemnify, defend and hold harmless Government, its elected and appointed officials, employees, agents, volunteers, and successors in interest, from and against any and all liability, damages, and losses, including but not limited to:

demands, claims, liens, suits, notices of violation from governmental agencies, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees that are in any way incidental to or connected with, or that arise or are alleged to have arisen, directly or indirectly, from or by Organization's performance of or breach of this Agreement and/or the provision of goods or services, provided that (a) it is attributable to personal injury, bodily injury, sickness, or death, or to injury to or destruction of property (including the loss of use resulting therefrom), or to or from the negligent acts, errors or omissions or willful misconduct of the Organization; and (b) not caused solely by willful misconduct of the Government. The Parties understand and agree that the Organization's obligation to defend the Government includes the obligation to investigate, handle, respond to, resist, provide a defense for, and defend claims, at Organization's expense, using attorneys approved in writing by the Government, which approval shall not be unreasonably withheld. The Parties also understand and agree that the Organization's obligation to indemnify includes, but is not limited to: attorney fees and expenses, costs of litigation, court and administrative costs, expert witness fees and expenses, judgments, fines, penalties, interest, all environmental cleanups and remediation costs of whatever kind, and any liability arising from death, injury, or damage of any kind, to any person, including employees and agents of Organization and Government, and damage to, or destruction of, any property, including the property of Government. This provision shall in no way be limited by any financial responsibility or insurance requirements, and shall survive the termination of this Agreement. Organization understands that Government is a political subdivision of the Commonwealth of Kentucky and acknowledges and agrees that the Government is unable to provide indemnity or otherwise save, hold harmless, or defend the Organization in any manner.

7. Organization represents that it has filed all federal, state and local income tax returns required by law in the legally prescribed time and manner. This Agreement shall not become effective unless and until copies of all of the executed originals of the aforementioned tax returns filed for the Organization have been registered for the current tax year by the Organization in the office of the Sponsor, and the Organization shall not be compensated unless and until such registration has taken place.

8. The Organization shall, on such forms as the Sponsor shall provide, submit to Sponsor an annual report and financial statement which summarize the previous year's activities regarding the services enumerated in Exhibits A and B attached hereto.

9. Books of accounts shall be kept by the Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of the Organization. The books of accounts, together with all bonds, notes, bills, letters and other writings belonging to the Organization, shall be maintained at the principal place of business of the Organization as set forth in this Agreement. Government shall have free and complete access to the books, papers and affairs of the Organization, that relate to the performance of this Agreement, at all reasonable times, and if it desires, it may have the books and papers of the Organization, that relate to the performance of this Agreement, audited and examined by auditors, accountants or attorneys. Any examination shall be at the expense of the Government.

10. Government may designate such persons as may be necessary to monitor and evaluate the services rendered by the Organization. The Government, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and monitoring of the work by these authorities shall in no manner be presumed to relieve in any degree the

responsibility or obligations of Organization, nor to constitute the Organization as an agent of the Government.

11. Organization shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and shall cause each of its subcontracting agencies to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

12. Organization shall adopt a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be submitted to Sponsor for review within thirty (30) days of the execution of this Agreement.

13. This instrument, and additional documents attached hereto, contains the entire agreement between the parties, and no statement, promises or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid and binding; and this Agreement may not be enlarged, modified or altered except in writing signed by the parties and endorsed hereon.

14. Organization agrees that it shall apply all funds received by it from the Urban County Government in accordance with the following investment policy guidelines:

- A. Objectives: Capital preservation with surety of income. Reasonable competitive income consistent with high investment quality and purpose of funds. All investments shall conform with state and local law and regulations and these policies.
- B. Investment Funds Management: The governing board may elect to either:

(1) Manage its investment through its executive director where the size or complexity of funds to be managed is deemed by the board to be within the training, expertise and/or available time capacity of the executive director and the operating staff; or

(2) Utilize the professional investment management facilities of a local bank trust department acting in a fiduciary capacity within the same approved investment policies and federal, state, local and trust laws and regulation. The trust department may utilize its regular short-term one hundred percent (100%) US Treasury Fund for daily funds investment.

The election of option 1 or 2 should be made consistent with the relative cost incurred and in the case of option 2 the cost shall be competitive among local trust departments.

C. Investment Policies - - Safety and Prudence.

(1) Short-term liquidity funds shall be invested in "riskless" investment, i.e., deposits in Kentucky commercial banks or savings and loan associations that are fully federally insured or deposits collateralized by U.S. Treasury securities with a current market value of at least one hundred percent (100%), or in direct obligations of U.S. Treasury securities.

Investments shall be diversified according to maturity in order to meet projected cash flow needs.

Collateral pledged to secure uninsured deposits shall be held at a federal reserve bank with the receipt providing absolute control by the agency.

(2) Retirement funds, endowment funds, long-term capital reserve funds and any other special funds may be held and invested by a local bank trust department under investment objectives and diversification in accordance with the individual nature of the funds and pursuant to the "prudent man" investment rule as well as general trust law.

(3) All investments shall be reviewed monthly by a finance or investment committee of the agency.

(4) Local brokerage firms may hold and invest funds provided that investments are located within Kentucky and are full insured.

D. Audit - - All investments shall be audited at least annually by independent certified public accountant who shall express an opinion as to whether or not investments during the year audited have conformed with state and local law and regulation and with the approved investment policies.

# 5.1 Program Proposal & Design

#### 5.1.1 Needs Statement—Purpose of the Program Proposal / Problem Statement

Access to affordable healthcare is a significant need in Fayette County. The pandemic highlighted this and exposed the issue of health inequities in the healthcare system. Currently, there are more than 28,000 uninsured individuals in Fayette County. Roughly 51,000 people find themselves underinsured or relying on Medicaid, which is limited in coverage and scope of care, particularly in dental and mental health coverage. Baptist Health 2022-2024 community assessment participants reported the largest barrier of care as the inability to afford copays and deductibles. The mental health patient to provider ratio is 260:1 in Fayette County, with many mental health providers not accepting Medicaid. The Kentucky Dental Association reported 52% of Kentuckians are unable to see a dentist due to the cost. Refuge Clinic receives an average of 10-15 new dental patient requests a week. The need for free healthcare outweighs the available resources. Refuge clinic is among a limited number of free healthcare services available in Fayette County and focuses its resources on the most at risk in the community to experience health disparities by providing free medical, dental and behavioral health services. All patients live 200% below Federal Poverty Guidelines, reside in Fayette or Jessamine County and are uninsured or underinsured with 55% of patients being minorities. Refuge Clinic serves as a safety net, partnering with local hospitals to provide primary care for individuals who otherwise would utilize the ER for a primary care source.

#### 5.1.2 Service Delivery Model

Refuge Clinic provides free comprehensive medical and dental care, women's health services, diabetic education, counseling and psychiatric services. Dental services include cleanings, fillings, x-rays, extractions, dentures, oral surgery, crowns and root canals. Services are provided Monday through Friday from 8:30-4:30 by volunteer providers with an average of 26 medical clinics, 23 dental clinics and 16 behavioral health clinics each month. Medical, dental and behavioral health services last an average of 1 hour in duration with access to free medications, specialist referrals, laboratory services, educational training on disease processes, translation and transportation services. The patient advocacy team is available to each patient as needed to address barriers in care, with average consultations lasting 30 minutes. The multidisciplinary team works to create goals with patients, utilizing clinical resources to achieve goals. All services are provided to the most at risk men and women as identified by their financial and social health determinants. Approximately 1,400 individuals will receive access to free healthcare and wraparound services through the clinic. In 2021, Refuge Clinic provided 2,700 units of service and welcomed 260 new patients in addition to the 5,000 individuals who received services since the clinic opened in 2008.

#### 5.1.3 Client Eligibility and Requirements

In order to receive services from Refuge Clinic, patients must be uninsured or underinsured, living 200% below Federal Poverty Guidelines and reside in Fayette or Jessamine County. Currently, 47% of the patient population is deemed underinsured. Patients are not expected to pay for any service they receive at the clinic, but verification of income and address at their first appointment are required. The administrative services coordinator verifies income level and address on an annual basis. Refuge Clinic works closely with patients to follow patient guidelines which include agreeing to be respectful of volunteers and staff, keeping appointments as scheduled, showing up on time and following recommended treatment plans including referral appointments. When a patient does not comply with expectations as outlined by the patient guidelines, it is not possible to deliver optimal care. When compliance is broken three times without adequate reason, patients will be discharged to respect the needs of others waiting to receive services.

#### 5.1.4 Evidence-Based/Best Practice

Refuge Clinic operates with an integrated relational healthcare model, speaking to every component of a patient's life in order to achieve optimal health and wellness. This model enables providers to deliver care uninhibited by financial or time constraints, giving providers the opportunity to spend adequate time with patients to develop relationships. When patients feel their provider is invested in their health they are more likely to follow treatment plans and work towards goals themselves. According to the World Health Organization, an integrated care model, which blends behavioral healthcare with physical care, is the best type of practice in order for patients to achieve best overall health. Various credible sources including SAMSHA, the Economic and Social Research Institute and the CDC all support multidisciplinary care models stating how it promotes high quality, patient centered care that improves overall health for patients. Strong patient-provider relationships facilitate greater cooperation and allow more insight to the unique needs of each patient in order to best care for them. This enables the provider to create a treatment plan catering to the physical, emotional, spiritual, social, environmental and intellectual needs of each patient.

Through utilizing an integrated relational healthcare model, Refuge Clinic lays a unique foundation for patients and providers to work together towards achieving improved overall health.

# 5.2 Program Measures & Evaluation

#### 5.2.1 Service Efficacy & Desired Outcomes

Refuge Clinic strives to improve the overall health of each patient by speaking to their physical, mental and social needs. The goal is to support patients in achieving optimal health and social wellbeing. Relational healthcare is imperative in achieving best health outcomes. Authentic relationships between the healthcare team and the patient establishes respect, accountability, and ownership in the healthcare plan. Providers work with patients to monitor long term disease processes, establish healthy lifestyle routines and create medication regimens to stabilize health conditions and enhance health outcomes. Refuge Clinic is multifaceted and multidisciplinary in approach, addressing all components of health. The dental clinic works towards relieving patients of dental pain while also improving oral health and self esteem in the process of restoring smiles through dentures and partials. The behavioral health component of care provides counseling and psychiatric services to improve mental health and implement habits to better cope with stress, anxiety and grief in their life.

Refuge Clinic measures success in programs by over 1,400 uninsured and underinsured people receiving services annually, 50% of patients utilizing the clinic for multiple services, and maintaining a no show rate lower than the average Medicaid noshow rate of 28%. Success will be measured by 75% of Refuge Clinic patients seeing improvement in their health, evident by controlled disease processes, pain relief and mental and social support.

#### 5.2.2 Client Empowerment & Community Impact

A person reaching their full potential not only improves the life of the individual, but improves the social sphere around that person and ripples into the community as a whole. Improved oral, physical and emotional health equates to less missed days of work and increased productivity overall. As patients see an improvement in their health there is an increase in self value and self esteem along with relief from pain and physical distress. In addition to physical health, when patients are emotionally healthy it leads to improved quality of life, resilience and their ability to be an active, engaged member of the community. The clinic is committed to providing the highest standard of healthcare to patients, building relationships where patients feel empowered to take control of their own health decisions in order to better their lives and in turn the lives of those around them.

One patient commented on how her experience at the clinic changed her outlook on the healthcare system by saying, "It gave me hope to know that people are out there that actually care. It gives me reassurance in humankind that people actually want to help me." Another patient shared, "My experience here has been great! The clinic helped me be consistent with medication and I've been able to get a job and a driver's license, and I wasn't able to do that before."

Refuge Clinic evaluates the effectiveness of services through annual chart audits to assess treatment plans and protocols, making adjustments to ensure desired outcomes for patients are met. Prevention screenings are performed on each patient to identify potential health risks before symptoms are present and to keep health problems from developing into chronic conditions. The Community Advisory Committee consists of active Refuge Clinic patients and meets biannually to provide feedback to help steer future decisions and resources, speaking to the largest needs. Refuge Clinic maintains various teams of healthcare professionals to evaluate systems, data and outcomes in their respective departments each month. The patient advocate team identifies barriers to care and any gaps in services while the clinical care team evaluates the clinical systems quarterly to improve overall quality of care. The Refuge Clinic Board and leadership team evaluates comprehensive data, surveying the total number of patient visits, new patients and patient encounters each month to measure success and evaluate how appropriately resources are being used to meet the needs of the community based on local metrics.

# 5.3 Capacity & Sustainability

Spiritual & Mental Health Coordinator, Derek Sloan, BS Youth and Family Ministry, MA Christian Leadership, LPCC and LCADC. Cultivates opportunities for spiritual and mental health among patients through building relationships, offering counseling and pastoral care services, identifying social barriers to healthcare, and community building as well as equip a team of volunteer leaders to serve.

Clinical Care Coordinator, Sandi Chinn, RN - Oversees all medical clinics, trains and equips medical volunteers, manages medical supply inventory, provides nursing care and ensures patient follow up.

Dental Coordinator, Cady Jean-Baptiste, X-Ray Certified, OSHA trained, 6 years dental experience - Coordinates all dental clinics, schedules providers for dental clinics, assists providers and oversees dental clinic supplies.

Dentist, Dr. Charis Brooks, DMD, 10 years experience with FQHCs in underserved areas of Kentucky - provides comprehensive dental care for patients.

Administrative Services Coordinator, Kate Witten, BS Family Science, 5 years administrative experience - New patient processing for all patients, managing and overseeing clinical schedules, answering and returning phone calls and medical record requests.

Refuge Clinic operates with highly esteemed healthcare volunteer leaders to oversee various departments, including Dr. Greg McMorrow, MD, Medical Director and Dr. Jon Bott, DMD, Dental Director. Refuge Clinic also relies on key volunteer informants who are knowledgeable in their field of practice including Dr. Sid Shih, MD of Psychiatry, advising in mental health matters, and Dr. Kent Davis, MD, Addictionologist, advising in Substance Misuse Disorders.

#### 5.3.2 Partnership & Resource Leverage

Providing healthcare, education and preventative services to the community creates improved community wellness through the positive impact made on individuals and families.

Refuge Clinic partners with Natalie's Sisters, Refuge for Women, Hope Center, Lexington Rescue Mission, Lexington Leadership Foundation, Kentucky Refugee Ministries, Homeless and Housing Coalition of Kentucky, Salvation Army, Lexington Fire Department, God's Pantry, UK Polk Dalton, Baby's Health, Jessamine County Health Department, Fayette County Health Department, Mission Lexington, Community Paramedicine, The Nest, LexCares, Community Action, Catholic Action Center, Christians in Community Service, Kentucky Cancer Link, Lexington Fair Housing Council and Kentucky Prescription Assistance Program in order to achieve best outcomes for all patients.

Volunteers provide free clinical services, committing to serve for a one year minimum. The clinic board is composed of leaders committed to upholding the vision and purpose of Refuge Clinic. Staff, volunteers and board members all carry responsibility to invite financial support for ongoing delivery of services.

Key financial partners include Baptist Health, Southland Christian Church, The Copia Foundation and Delta Dental of Kentucky. These partners share a like mindedness and focus on improved community health and wellness.

Southland Christian Church commits to 25% of the budget, with Baptist Health covering 8% of the budget. Through partnerships, Refuge Clinic operates from a free facility space, has pharmaceutical support through Lexington Compounding Pharmacy and Spencer Drug, and receives discounted services through Quest Diagnostics, McKesson and Patterson Dental. Refuge Clinic's pharmaceutical and laboratory partnerships saved the clinic over \$190,000 last year.

#### 5.3.3 Outreach & Inclusion Strategy

Refuge Clinic facilities are all ADA compliant and all services are provided to patients free of charge in order to remove any financial burdens. Clinic staff and volunteers identify barriers to care when performing medical, mental and social screenings, recognizing and addressing any economic or social determinants preventing patients from receiving optimal care. Utilizing an interdisciplinary approach, the clinic maintains teams of people ready to support patients with any physical, mental or social barrier to healthcare. Refuge Clinic upholds the Mayor's commission of Racial Justice & Equality through providing care to individuals who otherwise would go without access to care. The patient population consists of 55% minorities who often find themselves on the fringes of the healthcare system due to health inequities. Refuge Clinic is committed to address these determinants of health to achieve best outcome for all patients.

#### Laws and Regulations

All applicable state laws, municipal ordinances and regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

#### Equal Employment Opportunity

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and to promote equal employment through a positive, continuing program from itself and each of its subcontracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

#### Kentucky Equal Employment Opportunity Act

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

(1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;

(2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;

(3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and

(4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers' representative of the contractor's commitments under the nondiscrimination clauses."

The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

(1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.

(2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

(1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.

(2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may

cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the contractor complies in full with the requirements of KRS 45.560 to 45.640.

(3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as <u>special conditions</u> in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available work-force in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

#### LFUCG Non-Appropriation Clause

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

#### GENERAL PROVISIONS

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

The Respondent agrees to comply with all statutes, rules, and regulations governing safe and healthful working conditions, including the Occupational Health and Safety Act of 1970, *29 U.S.C. 650 et. seq.*, as amended, and KRS Chapter 338. The Respondent also agrees to notify the LFUCG in writing immediately upon detection of any unsafe and/or unhealthful working conditions at the job site. The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

- 2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.
- 3. Addenda: All addenda, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. Before submitting a proposal, it is incumbent upon each proposer to be informed as to whether any addenda have been issued, and the failure to cover in the bid any such addenda may result in disqualification of that proposal.
- 4. Proposal Reservations: LFUCG reserves the right to reject any or all proposals, to award in whole or part, and to waive minor immaterial defects in proposals. LFUCG may consider any alternative proposal that meets its basic needs.
- 5. Liability: LFUCG is not responsible for any cost incurred by a Respondent in the preparation of proposals.
- 6. Changes/Alterations: Respondent may change or withdraw a proposal at any time prior to the opening; however, no oral modifications will be allowed. Only letters, or other formal written requests for modifications or

corrections of a previously submitted proposal which is addressed in the same manner as the proposal, and received by LFUCG prior to the scheduled closing time for receipt of proposals, will be accepted. The proposal, when opened, will then be corrected in accordance with such written request(s), provided that the written request is contained in a sealed envelope which is plainly marked "modifications of proposal".

- 7. Clarification of Submittal: LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
- 8. Bribery Clause: By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted to bribe an officer or employee of the LFUCG.
- 9. Additional Information: While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal,
- 10. Ambiguity, Conflict or other Errors in RFP: If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
- 11. Agreement to RFP Terms: In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract/Grant under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
- 12. Cancellation: If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the cancellation if such action is in its best interest.

- A. Termination for Cause
- (1) LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties
- (2) If a contractor is determined to be in default, LFUCG shall notify the contractor of the determination in writing, and may include a specified date by which the contractor shall cure the identified deficiencies. LFUCG may proceed with termination if the contractor fails to cure the deficiencies within the specified time.
- (3) A default in performance by a contractor for which a contract may be terminated shall include, but shall not necessarily be limited to:
  - (a) Failure to perform the contract according to its terms, conditions and specifications;
  - (b) Failure to make delivery within the time specified or according to a delivery schedule fixed by the contract;
  - (c) Late payment or nonpayment of bills for labor, materials, supplies, or equipment furnished in connection with a contract for construction services as evidenced by mechanics' liens filed pursuant to the provisions of KRS Chapter 376, or letters of indebtedness received from creditors by the purchasing agency;
  - (d) Failure to diligently advance the work under a contract for construction services;
  - (e) The filing of a bankruptcy petition by or against the contractor; or
  - (f) Actions that endanger the health, safely or welfare of the LFUCG or its citizens.
- B. At Will Termination

Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent, Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

13. Assignment of Contract: The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. Any

purported assignment or subcontract in violation hereof shall be void. It is expressly acknowledged that LFUCG shall never be required or obligated to consent to any request for assignment or subcontract; and further that such refusal to consent can be for any or no reason, fully within the sole discretion of LFUCG.

- 14. No Waiver: No failure or delay by LFUCG in exercising any right, remedy, power or privilege hereunder, nor any single or partial exercise thereof, nor the exercise of any other right, remedy, power or privilege shall operate as a waiver hereof or thereof. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
- 15. Authority to do Business: The Respondent must be a duly organized and authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. The Respondent will provide LFUCG with a copy of a corporate resolution authorizing this action and a letter from an attorney confirming that the proposer is authorized to do business in the State of Kentucky if requested. All proposals must be signed by a duly authorized officer, agent or employee of the Respondent.

- 18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
- 19. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.

Each fiscal year the Mayor and Urban County Council allocate funds for use by selected 501(c)(3) nonprofit partner agencies through the Department of Social Services' Extended Social Resource (ESR) Program.

#### 2.0 GENERAL PROVISIONS

#### 2.1 Purpose

The LFUCG is accepting applications from qualified non-governmental, non-profit agencies with current **501(c)3** tax exempt status and with a physical business or program site location in Fayette County (hereinafter, referred to as "Applicant") for ESR funding for FY2023 & 2024 (July 1, 2022 – June 30, 2024). This funding is intended to support agency **programs** which respond to the **funding priorities** established herein. **THIS FUNDING IS NOT INTENDED TO SUPPORT GENERAL AGENCY OPERATIONS, other than overhead required to support the subject program.** 

#### 2.2 Funding Period

The funding period is from July 1, 2022 through June 30, 2024.

#### 2.3 ESR Grant Informational Workshop

The Department of Social Services conducted a meeting on January 20<sup>th</sup>, 2022 that provided potential proposers with an overview of the proposal and review process, instructions on completing the RFP, and presentation of funding priorities.

#### 2.4 **Proposal Submission**
