-) \$25,758.18 from the Unappropriated Fund Balance in the Water Quality Management Fund to various accounts.
-) \$5,935.62 from the Unappropriated Fund Balance in the Enhanced 911 Fund to various accounts.
-) \$4,320.00 from the Unappropriated Fund Balance in the Central Kentucky 911 Fund to various accounts.
