

DEED OF EASEMENT

This PERMANENT STORMWATER EASEMENT AND TEMPORARY CONSTRUCTION EASEMENT is made and entered into this the 26th day of October, 2022, by and between MARY HELEN BOSCH, a widow, 3475 Lyon Drive, Unit 69, Lexington, Kentucky 40513, which is the in-care of tax mailing address for the current year (hereinafter "Grantor"), and LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, 200 East Main Street, Lexington, Kentucky 40507 (hereinafter "Grantee").

WITNESSETH:

That for and in consideration of the sum of FIVE HUNDRED DOLLARS AND 00/100 CENTS (\$500.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantor has BARGAINED and SOLD and does hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and

Return to: Cynthia Cannon-Ferguson LFUCG, Dept. of Law, 11th Floor 200 East Main Street Lexington, KY 40507 assigns, permanent right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of stormwater improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, depicted on the attached Exhibit "A", and more particularly described as follows, to wit:

Permanent Stormwater Easement Lyon Drive Stormwater Improvement Project (a portion of 3475 Lyon Drive, Unit 69)

Drainage easements for a certain tract or parcel of land located on Lyon Drive in Lexington, Fayette County, Kentucky approximately 584 feet from the intersection of Lyon Drive and Ft. Harrods Drive and being more particularly described and bounded as follows:

Tract 69B

BEGINNING, at a nail and washer set in the east line of a parcel owned by Quail Run Townhouses Association, Inc. (formerly Harrods Hill Estates HOA) HOA Lot (Deed Book 1446, Page 43), Unit 2-H, Section 1-A (Plat Cabinet D, Slide 492), having a coordinate of N: 186674.67, E:1548405.91;

Thence a tie bearing of N 65° 21' 45" W, a distance of 161.96 feet to the common corner of Lot 70 (Nancye Smith, Deed Book 1418, Page 708) and Lot 69, and a point in the south line between Lot 18 and going with the line between Lot 69 and Lot 70, S 24°38'17" W, a distance of 4.38 feet (L1), which is the *TRUE POINT OF BEGINNING*, having a coordinate of N:186738.20, E:1548256.87; thence the following four calls:

- 1) Thence with the line between Lot 69 and Lot 70, S 24°38'17" W, a distance of 15.00 feet (L5) to a point in said line;
- 2) Thence leaving the line of Lot 70 and crossing Lot 69, N 64°38'43" W, a distance of 30.10 feet (L6) to a point in the line between Lot 68 (Alice Ann Cull Sanders, Deed Book 3171, Page 76) and Lot 69;

- 3) Thence with the line between Lot 68 and Lot 69, N 24°38'15" E, a distance of 15.00 feet (L7) to a point in said line;
- 4) Thence leaving Lot 68 and crossing Lot 69, S 64°38'43" E, a distance of 30.10 feet (L8) back to the **TRUE POINT OF BEGINNING**; and,

The above-described parcel contains 0.0104 Acres (452 sq. ft.) of permanent easement; and

Tract 69B, being a portion of the same property conveyed to Mary Helen Bosch, a married person (now a widow), by Deed dated October 23, 2019, of record in Deed Book 3710, Page 129, in the Fayette County Clerk's Office. Said Glen D. Bosch, died intestate on October 1, 2021, a resident of Lexington, Fayette County, Kentucky.

FURTHER, for and in consideration of the sum hereinbefore mentioned, the receipt and sufficiency of which is hereby acknowledged, Grantor has BARGAINED and SOLD and does hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of stormwater improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, depicted on Exhibit "A" attached hereto, and more particularly described as follows:

Temporary Construction Easement

Tract 69A

BEGINNING, at a nail and washer set in the east line of a parcel owned by Quail Run Townhouses Association, Inc. (formerly Harrods Hill Estates HOA) HOA Lot (Deed Book 1446, Page 43), Unit 2-H, Section 1-A (Plat Cabinet D, Slide 492), having a coordinate of N: 186674.67 E:1548405.91;

Thence a tie bearing of N 65° 21' 45" W, a distance of 161.96 feet to the common corner of Lot 70 (Nancye Smith, Deed Book 1418, Page 708) and Lot 69, and a point in the south line of Lot 18 (Virginia L. Bradley, Deed Book 2022, Page 671), which is the *TRUE POINT OF BEGINNING*, having a coordinate of N:186742.18, E:1548258.72; thence the following four calls:

- 1) Thence with the line between Lot 69 and Lot 70, S 24°38'17" W, a distance of 4.38 feet (L1) to a point in said line;
- 2) Thence leaving the line Lot 70 and crossing Lot 69, N 64°38'43" W, a distance of 30.10 feet (L2) to a point in the line between Lot 68 (Alice Ann Cull Sanders, Deed Book 3171, Page 76) and Lot 69:
- 3) Thence with the line, N 24°38'15" E, a distance of 4.00 feet (L3) to a point in the southern line of Lot 19 (Karen R. Alexander, Deed Book 2143, Page 600);
- 4) Thence with said line, S 65°21'46" E, leaving the line of Lot 19 at 27.98 feet and continuing with the line of Lot 18 (Virginia L. Bradley, Deed Book 2022, Page 671) to the <u>TRUE POINT OF BEGINNING</u>, a total distance of 30.10 feet (L4); and,

The above described parcel contains 0.0029 Acres (126 sq. ft.) of temporary construction easement; and

Tract 69C

BEGINNING, at a nail and washer set in the east line of a tract owned by Quail Run Townhouses Association, Inc. (formerly Harrods Hill Estates HOA) HOA Lot (Deed Book 1446, Page 43), Unit 2-H, Section 1-A (Plat Cabinet D, Slide 492), having a coordinate of N: 186674.67, E:1548405.91;

Thence a tie bearing of N 65° 21' 45" W, a distance of 161.96 feet to a common corner of Lot 70 (Nancye Smith, Deed Book 1418, Page 708) and Lot 69, and a point in the south line of Lot 18 (Virginia L. Bradley, Deed Book 2022, Page 671); thence leaving Lot 18 and going with the line between Lot 69 and Lot 70, S 24°38'17" W, a distance of

4.38 feet (L1) to a point in said line; thence continuing with said line of Lot 70, S 24°38'17" W, a distance of 15.00 feet, which is the *TRUE POINT OF BEGINNING*, having a coordinate of N:186724.56, E:1548250.64; thence the following four calls:

- Thence continuing with the line between Lot 69 and Lot 70, S 24°38'17" W, a distance of 5.00 feet (L9) to a point in said line;
- 2) Thence leaving the line of Lot 70 and crossing Lot 69, N 64°38'43" W, a distance of 30.13 feet (L10) to a point in the line between Lot 68 (Alice Ann Cull Sanders, Deed Book 3171, Page 76) and Lot 69;
- 3) Thence with said line between Lot 68 and Lot 69, N 24°38'15" E, a distance of 5.00 feet (L11) to a point in said line;
- 4) Thence leaving Lot 68 and crossing Lot 69, S 64°38'43" E, a distance of 30.10 feet (L12) back to the <u>TRUE POINT OF BEGINNING</u>; and,

The above described parcel contains 0.0035 Acres (151 sq. ft.) of temporary construction easement; and

Tract 69A and Tract 69C, being a portion of the same property conveyed to Mary Helen Bosch, a married person (now a widow), by Deed dated October 23, 2019, of record in Deed Book 3710, Page 129, in the Fayette County Clerk's Office. Said Glen D. Bosch, died intestate on October 1, 2021, a resident of Lexington, Fayette County, Kentucky.

TO HAVE AND TO HOLD the above-described easements together with all rights, appurtenances, and improvements thereunto belonging unto Grantee, its successors and assigns forever, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project and is binding upon the successors and assigns of the Grantor. The above-described permanent easement runs with the land in perpetuity

and is binding upon the successors and assigns of the Grantor. The temporary

construction easement shall take effect upon the commencement of construction of the

project and will expire upon completion of the project.

Grantor shall have the full right to use the surface of the land lying over said

permanent easement for any purpose desired, provided such use will not interfere with

the Grantee's free use of the easement herein granted and provided further that no

building or structure shall be erected upon, across, over or through said permanent

easement without prior written consent of the Grantee.

Grantor does hereby release and relinquish unto the Grantee, its successors and

assigns forever, all of her right, title, and interest in and to the property to the extent of

the interests conveyed herein, including all exemptions allowed by law, and does

hereby covenant to and with the Grantee, its successors and assigns forever, that she

is lawfully seized in fee simple of said property and has good right to sell and convey

the easements as herein done, and she will WARRANT GENERALLY said title.

The obtaining of this easement was authorized by Resolution 458-2022, passed

by the Lexington-Fayette Urban County Council on August 30, 2022. Pursuant to KRS

382.135(2)(a), this deed of easement, which pertains to a public utility, need not contain

a statement of consideration.


