

Lexington- Fayette Urban County Government Council Meeting

Lexington, Kentucky October 13, 2022

An Ordinance amending certain of the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures, and appropriating and re-appropriating funds, FY 2023 Schedule No. 13.

An Ordinance creating Section 8-1(D)(33) and amending Section 1-11 of the Zoning Ordinance to create a new conditional use for Small Farm Micro-Distilleries in the Agricultural-Rural (A-R) Zone (Silver Springs Farm Eqwine and Vineyard, LLC) was on the docket to receive first reading.

Upon motion by Ms. Lamb, seconded by Ms. Plomin, and approved by majority vote (Mr. Worley was absent), the Ordinance was amended to include the following: Small farm Micro-Distillery means a distillery located on an active farm, that produces less than 1,000 gallons of distilled spirit annually, and operated under a Class B License as defined in KRS 243.140. The distillery may include all accessory activities as permitted in KRS 243.0305 and 243.035, without limitation. Such uses include product sampling, souvenir package sales, retail drink sale, and bottling.

Chief Lawrence Weathers, Div. of Police, presented a disciplinary matter regarding Officer Kevin Preston. An allegation has been made that Officer Preston has committed the offense of Body Worn Camera Procedures & Accountability and Responsibility which constitutes misconduct under the provisions of KRS 95.450 and/or KRS 15.520 and General Order 1973-02K Disciplinary Procedures of Sworn Officers Section 1.04 and Section 1.08 in that on the 12th and 13th day(s) of July 2022, he/she allegedly:

- (1) On July 12th and 13th, 2022 Officer Kevin Preston reported to work feeling ill and stayed in the parking garage during his shifts. During those two duty days he did not respond to any calls for service. Also during this timeframe, Officer Preston failed to power on his Body Worn Camera. The above policies state:

- Officers are directly accountable for their actions, through the chain of command, to the Chief of Police. Officers shall report for duty, including court and overtime assignments, at the time and place required, being both physically and mentally fit, and properly equipped and aware of the information required for the proper performance of their duties.
- Officers issued Body-Worn Cameras shall wear and use them, as outlined in department policies, to record contacts and interactions that occur between officers and members of the public, suspects, and others in a wide variety of situations to promote transparency in accordance with state law and accountability for officers and the community through objective evidence.

This is Officer Preston's first sustained formal complaint since his employment since March 18, 2013.

The appropriate punishment for this conduct is Written Reprimand.

Upon motion by Mr. McCurn, seconded by Ms. Bledsoe and approved by majority vote (Mr. Worley was absent), the disciplinary recommendation was approved.
