SECOND AMENDMENT TO AMERICAN RESCUE PLAN ACT OF 2021 SUBRECIPIENT AGREEMENT

RECITALS

WHEREAS, pursuant to Urban County Council Resolution No. R-618-2019, the Government and Subrecipient executed the original agreement setting forth the terms and conditions under with Subrecipient would operate and provide an Intensive Street Case Management Program in response to RFP No. 30-2019; and

WHEREAS, pursuant to Urban County Council Resolution No. R-510-2021, the Government and Subrecipient executed a new written agreement (the "Subrecipient Agreement"), in which Subrecipient was allocated \$392,000.00 in federal funds from the U.S. Department of Treasury, under the American Rescue Plan Act of 2021, to continue operation of the Intensive Street Outreach Program; and

WHEREAS, pursuant to Urban County Council Resolution No. R-665-2022, the Government and Subrecipient executed a First Amendment to the Subrecipient Agreement to expand the use of federal funds, as well as additional non-federal funds, for services authorized under the Subrecipient Agreement to allow Subrecipient to facilitate motel vouchers for unsheltered persons during activations of emergency winter weather plan; and

WHEREAS, the term of the Subrecipient Agreement, as amended, ends on June 30, 2023, and Subrecipient desires to extend the period of performance for the operation of the Intensive Street Outreach Program, at no additional cost to the Government, in order to use the remaining funds; and

WHEREAS, the parties mutually agree to enter this Second Amendment to extend the term of the Subrecipient Agreement, as amended, through September 30, 2023, upon the terms and conditions hereinafter set forth.

STATEMENT OF AGREEMENT

NOW, THEREFORE, in consideration of the foregoing and mutually agreed upon promises, conditions, and covenants set forth herein, the receipt and sufficiency of which are acknowledged, the parties hereby agree to further amend the Subrecipient Agreement, as amended by the First Amendment, as follows:

- 1. <u>Incorporation of Recitals</u>. The above recitals are incorporated herein as a part of this Second Amendment.
- 2. Amendment to Section I. Statement of Work.
 - a. <u>Section I.F. Schedule Time of Performance</u>. Section I.F. of the Subrecipient Agreement is amended and restated as follows:

"The term of this Agreement shall be from July 1, 2021, until September 30, 2023."

3. <u>Effect</u>. All other provisions of the Subrecipient Agreement, as amended by the First Amendment, which are attached hereto as Exhibits "A-1" and "B-1", respectively, and incorporated herein as if fully stated, not inconsistent with the provisions of this Second Amendment shall remain in full force and effect.
