## ADDITIONAL TERMS AND CONDITIONS:

- 1. ENGAGEMENT: Purchaser engages Artist, and Artist agrees, to perform at DATE, TIME and PLACE of performance specified for the compensation specified.
- 2. HALL: Purchaser agrees, at his own expense, to furnish the aforementioned Performing Space on the date and the time for the engagement herein contracted for, well heated, lighted, clean and in good order, clean dressing area for the Artist near the stage, and clean and adequate dressing area for accompanist and assisting artist or artists, and all other items included, but not limited to, musicians, singers and stage managers. Purchaser also agrees to provide bottled water for each performer.
- 3. And the Purchaser agrees, at Purchaser's expense, to print and distribute a sufficient quantity of the Teacher's Guide materials furnished by Artist.
- 4. IMPOSSIBILITY OF PERFORMANCE: Artist shall be under no liability for failure to appear or perform in the event that such failure is caused by or due to the physical disability of Artist, or acts or regulations of public authorities, labor difficulties, epidemic, civil tumult, strike, interruption or delay of transportation service, or any other similar or dissimilar cause beyond the control of Artist. If a subsequent date and time can be arranged, then Purchaser shall remain obligated in all respects of this agreement.
- 5. EXCUSE FROM PERFORMANCE: This agreement is made in reliance upon Purchaser's good reputation for the prompt discharge of all obligations. In the event that Purchaser shall default in making payment for the services of any one or more artists engaged through or from the University of Kentucky, Artist shall have the right to terminate this agreement by giving Purchaser notice in writing.
- 6. RESTRICTIONS: Purchaser agrees to prevent the broadcasting, recording, or reproduction by radio, television or any other recording device of Artist's performance, or any part thereof.
- 7. PERFORMANCE REFUSAL: In the event purchaser refuses or neglects to provide any of the terms herein stated and/or fails to make any of the payments as provided herein. Artist shall have the right to refuse to perform this contract, shall retain amounts therefore paid to Artist by Purchaser, and Purchaser shall remain liable to Artist for the agreed price stated herein set forth. Furthermore; In the event, after the contract has been signed by both parties, the Purchaser cancels the performance(s), the Purchaser shall pay a cancellation fee equal to 50% of the full price agreed upon stated herein set forth.
