WHEREAS, on June 29, 2016, the parties hereto entered into an agreement for the Town Branch Trail Commons-Midland Section Project; and


WHEREAS, the parties desire to amend said agreement;

## ATTACHMENT A SCOPE OF WORK AND BUDGET SUMMARY

## Scope of Work:

All federally-funded projects are set up in phases (design, ROW, utilities, construction). No work can begin on any phase of a project until the CABINET provides a written notice to proceed for that phase. Funding for this project will be programmed with FHWA as each phase is approved. As each phase of the project is programmed with FHWA a supplemental agreement will be sent to the project sponsor to add the funding and adjust the project end date. Any expenditure incurred by the project sponsor after the end date will not be eligible for reimbursement. If the project sponsor requires an extension, they must notify the Administering Office thirty (30) days before the project end date.

The scope of work for this project includes PE, environmental, design engineering, right-of-way and utilities for bike/ped facilities from main Street/Midland Avenue to Third Street at Legacy Trail.

This project has been allocated up to \$3,200,000 (including contingency) in federal funds for completion.
