SUBJECT: Amendment to the 2014-2019 Consolidated Plans –

**PUBLIC HEARING ON FEBRUARY 20, 2020** 

**Request:** Council authorization to approve and adopt a substantial amendment to the 2014, 2015, 2016, 2017, 2018, and 2019 Annual Action Plans to move funding from several completed Community Development Block Grant projects to new or existing projects and to budget program income resulting in a net zero change in expenses to LFUCG.

**Purpose of Request:** The Community Development Block Grant (CDBG) program has received additional program income of \$102,262.77 from loan receipts in the housing rehabilitation program and has a number of additional projects that were completed or changed without spending all allocated funds. It is necessary to reallocate unspent funds to other eligible activities in the program. Funding will be reallocated as follows:
