- C. Technical Specification 25. Storm Sewer Pipe The specification was updated with currently applicable ASTM requirements.
- D. Technical Specification 26. Internal Inspection of Sewer Pipe: CCTV The specification was updated with currently applicable ASTM requirements.
- E. Technical Specification 35. Sanitary Sewer Steel casing pipe and related ancillaries are added to this specification section. If utilized in a contract, it will be furnished and installed on a reimbursable labor and materials basis.
- F. Technical Specification 58. Thermoplastic Pavement Striping. New specification section and corresponding bid items.
