## **State Homeland Security Grant Program**

The State Homeland Security Grant Program (SHSGP) assist states to build, sustain, and deliver capabilities necessary to prevent, prepare for, protect against, and respond to acts of terrorism. To be funded, projects MUST (1) demonstrate a terroristic preparedness nexus, (2) address threats and hazards identified in the State's Threat and Hazards Identification and Risk Assessments (THIRAs) and the corresponding National Core Capabilities, and (3) fall under an identified National Priority Area or Enduring Security Need.

#### **General Procedures**

- Only eligible applicants may apply for these funds. Eligible applicants include city or county governments, area development districts, local taxing districts, and public school districts.
- An agency may submit multiple applications. However, each application may contain only one project and reflect only one funding category. Please consider your community's most critical need when applying for these limited funds.
- The lead applicant is responsible for grant funds and administration including, but not limited to, assurances and audit requirement, maintenance, and records retention.
- All applicants applying for federal grant awards MUST have an active DUNS number <a href="https://www.dnb.com/duns-number/get-a-duns.html">https://www.dnb.com/duns-number/get-a-duns.html</a>.
- All applicants applying for federal grant awards MUST have an eClearinghouse review. For instructions go to <a href="https://kydlgweb.ky.gov/FederalGrants/eClearinghouse.cfm">https://kydlgweb.ky.gov/FederalGrants/eClearinghouse.cfm</a>.
- All applicants applying for federal grant awards MUST be registered on SAM.gov. https://www.sam.gov/SAM/

## **Required Project Proposal Elements**

- Your proposal MUST demonstrate a terroristic preparedness nexus. Proposals may simultaneously support enhanced preparedness for disasters unrelated to acts of terrorism, BUT terrorism must be in the forefront.
- Your proposal MUST fall under one the previously identified National Priority Areas or Enduring Security Needs.
- Proposals will be evaluated on the ability to close Core Capability Gaps identified in FEMA's National Preparedness Goals that are associated with Threats/Hazards identified in Kentucky's Stakeholder Preparedness Review. Guidance is provided on the following page. Your proposal MUST be based on at least one Threat or Hazard that has been identified in Kentucky's Strategic Preparedness Report and at least one Core Capability from FEMA's National Preparedness Goals.

Proposals will be evaluated based on the following factors that MUST be included in your Project Narrative (Page 9-10):

- Investment Strategy (30%): Describe in narrative form how your project strategy effectively demonstrates the objectives of preventing, preparing for, protecting against, and responding to acts of terrorism. Proposals must address closing the gaps in applicants' identified core capabilities and reducing the overall risk to the community, state or nation.
- Collaboration (30%): Regional, statewide or multistate impact. Describe in narrative form the extent to which the project demonstrates a willingness to collaborate with federal, state, and local governments in efforts to prevent, prepare for, protect against, and respond to acts of terrorism and reduce the overall risk to the state or the nation.
- 3. **Budget Narrative** (10%): Describe in narrative form your budget plan, demonstrating how it will maximize cost effectiveness of grant expenditures. What is the plan for financial sustainability? Are local matching funds available? Does applicant have previous experience in grant management?
- 4. Impact/Outcomes (30%): Describe in narrative form the solution; describe in detail what will be accomplished by this project. Include what procedures will be implemented, what capabilities will be enhanced, how identified threats and hazards will be mitigated, and the ways in which the applicant will measure and/or evaluate improvement.



## Guidance for Gap Identification – Threat, Vulnerability, and Consequences

DHS/FEMA requires states, territories, and Urban Areas to complete a Threat and Hazard Identification and Risk Assessment (THIRA) and Stakeholder Preparedness Review (SPR) (formerly known as the State Preparedness Report) and prioritize grant funding to support closing capability gaps or sustaining capabilities identified in this process.

**Threat**: In considering threat, the applicant should discuss the potential for terroristic activity, domestic or international, faced by the community.

**Vulnerabilities:** In considering vulnerabilities, the applicant should discuss the community's susceptibility to destruction, incapacitation, or exploitation by a terroristic threat/attack.

**Consequences:** In considering potential consequences, the applicant should discuss potential negative effects on the community.

#### Civil Rights Act of 1964 – Title VI

These regulations restrict federal financial assistance awards, sub-awards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in federal assistance programs or activities.

#### **Drug-Free Workplace Regulations**

All recipients must comply with the Drug-Free Workplace Act of 1988 (41

#### False Claims Act and Program Fraud Civil Remedies

#### Federal Debt Status

#### Hotel and Motel Fire Safety Act of 1990
