Request:

The attached is requesting authorization to abolish two (2) vacant classified positions of Public Service Worker Sr. (Grade 509N), two (2) vacant classified positions of Public Service Worker Sr. (Grade 509) in the Divisions of Streets & Roads and Water Quality and one (1) vacant classified position of Equipment Operator Sr. (Grade 512N) in the Division of Waste Management and also create two (2) unclassified positions of Public Works Apprentice (Grade 504N) in the Division of Streets & Roads, two (2) unclassified positions of Public Works Apprentice (Grade 504N) in the Division of Waster Quality and two (2) unclassified positions of Public Works Apprentice (Grade 504N) in the Division of Waster Management, effective upon passage by Council.

Why are you requesting?

Upon the request of the division, and in accordance with the Code of Ordinances, the Division of Human Resources conducted a classification studies on the requested positions. These studies were conducted according to standard procedures using the Job Analysis Questionnaire (JAQ) and position audit. The positions were analyzed by staff using the whole job rank and factor comparison methods. As a result, recommendations for their requested positions as described in this action.

What is the cost in the budget year and future budget year?

To illustrate, this has a 12-month future impact of a savings of \$14,695.49.
