This Amendment Is made and entered into by and between the Kentucky Transportation Cabinet (KYTC) and the Lexington-Fayette Urban County Government (RECIPIENT) acting as an amendment to that Agreement entered into between the parties dated October 18, 2017.

WHEREAS, on October 18, 2017, the parties hereto entered into an agreement for the Mercer Road at Greendale Road Turn Lanes project; and

WHEREAS, the parties desire to amend said agreement;

NOW THEREFORE, in consideration of the following promises and covenants contained herein the parties hereby agree as follows:

- 1. The KYTC will be the lead agency for the construction turn lane improvements at Mercer Road (KY 1257) and Greendale Road in Lexington, Kentucky;
- 2. The KYTC will use federal Congestion Mitigation and Air Quality (CMAQ) funding for the project and the RECIPIENT agrees to provide a match of twenty percent (20%) of the total construction costs of \$634,765, and agrees to provide a match of twenty percent (20%) for any required change orders;
- 3. The KYTC will be responsible for construction inspection activities, and will provide the required twenty percent (20%) match for the federal funding for the construction inspection costs;
- 4. The KYTC will notify the RECIPIENT of any required construction change orders that will result in an increase in construction costs;
- 5. Beginning the quarter following the notice to proceed to the contractor, the KYTC will invoice the RECIPIENT quarterly for the twenty percent (20%) project match based on the quarterly construction expenditures;
- 6. The RECIPIENT will retain responsibility for the facilities once the project is complete;
- 7. All other terms and conditions of the original Agreement shall remain in effect.
