The AOC will reimburse LFUCG for the full amount of construction services not exceeding \$396,700 in monthly payments. The Addendum will revise the date June 30, 2020, to June 30, 2021 as the date in which AOC funds appropriations end. Original MOU: R-083-2020. Funds are budgeted. (L0986-20) (Baradaran/Conrad)
