Authorization for LFUCG, Division of Fire and Emergency Services to enter into an agreement with the University of Kentucky in order for them to provide the Division of Fire with six ME1 keys that will be used to access construction fencing gates and to ensure that the Fire Department can respond inside of a fenced construction site unimpeded. No budgetary impact. (L1024-20) (Chilton/Armstrong)
