The State Criminal Alien Assistance Program provides funds to States and localities as reimbursement for costs of incarcerated undocumented aliens who have been incarcerated for at least four (4) consecutive days from July 1, 2013 to June 30, 2014, and incarcerated on conviction of at least one (1) felony or two (2) misdemeanors. BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to accept a grant from the U.S. Department of Justice, which Grant funds are in the amount of \$42,100.00 Federal funds, under the State Criminal Alien Assistance program (SCAAP) for the reimbursement of costs related to the incarceration of undocumented criminal aliens, the acceptance of which does not obligate the Lexington-Fayette Urban County Government for the expenditure of funds.

Section 2 - That subject to the provisions of Ordinance No. 22-79, the Mayor is hereby authorized, in his discretion as Chief Executive Officer of the Urban County Government, to transfer the unencumbered balance of any operating or capital account appropriation to another operating or capital account appropriation within the Grant budget previously established for this Grant.

Section 3 - That this Resolution shall become effective on the date of its passage.
