Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute Change Order No.

Four (4), which is attached hereto and incorporated herein by reference, to the Agreement with Pace Contracting, for the Town Branch Commons Corridor Construction Project, increasing the contract price by \$177,159.21 and raising the total contract price from \$21,920,359.57 to \$22,097,518.78, pending approval from the Kentucky Transportation Cabinet.

Section 2 - That an amount, not to exceed the sum of \$177,159.21, is hereby authorized for payment to Pace Contracting, from account # 3160-303202-3225-90313-2016-TOWN\_COM\_2016-CONSTRUCT (\$47.35), # 3160-303202-3225-91715-2016- TOWN\_LEX\_2016-CONSTRUCT (\$39.32) and # 3160-303202-3225-90313-2017- TOWN\_TGER\_2017-CONSTRUCT (\$177,072.54), pursuant to the terms of Change Order Four (4).

Section 3 - That this Resolution shall become effective on the date of its passage.
