WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government for Council appropriations for the ADA Improvement Plan from American Rescue Plan act (ARPA) State and Local Recovery Funds, as approved November 1, 2022:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended for Council appropriations for ADA Improvement Plan from American Rescue Plan act (ARPA) State and Local Recovery Funds, as approved November 1, 2022 and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
