Section 2 - That an amount, not to exceed the sum of \$131,597, be and hereby is approved, for payment to Kentucky Community & Technical College System on behalf of Bluegrass Community and Technical College, for FY2025, subject to appropriation by Council, from account # 1101-505507-71302, pursuant to the terms of the Memorandum of Agreement.
