BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 3 - That an amount, not to exceed the sum of \$14,670.00 for FY 2016, be and hereby is approved for payment to Windstream Communications, LLC from account #1101-202505-72202, pursuant to the terms of the Agreement.

Section 4 - That this Resolution shall become effective on the date of its passage.
