(Resolution #195-2023) for the Lexington Police Department Firing Range to allow for the addition of burglary monitoring to the on-site Storage Building, as well as an Addendum to this Agreement to extend the term for a period of five (5) years from the date installation is completed, pursuant to the schedule.
