WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended for Affordable Housing in the amount of \$10,000,000 out of American Rescue Plan Act funds as approved at Work Session October 26, 2021, and that to effect such Amendments the following appropriations be and hereby are

authorized and directed:
