WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

-) \$ 21,200.00 __from__ Sanitary Sewer Revenue and Operating Fund __to__ various accounts.
-) \$ 10,800.00 __from__ Water Quality Management Fund __to__ various accounts.
-) \$ 8,000.00 __from__ Landfill Fund __to__ various accounts.
-) Re-appropriations within the General Services District Fund; General Fund Capital Projects Fund; and various Grant funds

that do not result in changes to the Unappropriated Fund Balance of these funds.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0029" attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its

) \$10,800.00 from Water Quality Management Fund to various accounts.

) \$8,000.00 from Landfill Fund to various accounts.

) Re-appropriations within the General Services District Fund; General Fund Capital Projects Fund; and various grant funds that do not result in changes to the Unappropriated Fund Balance of these funds.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0029" attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
