Upon the request of the division, and in accordance with Section 21-2 (d) of the Code of Ordinances, the Division of Human Resources conducted a classification study on the requested position. As a result, a recommendation for their requested position as described in this action. To illustrate, this has a 12-month future impact of a savings of \$9,049.15. Funds are budgeted.
