Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute Change Order No. 1, which is attached hereto and incorporated herein by reference, to the Contract with Omni Commercial, LLC, for the New Restroom and Concession Building for Lansdowne Merrick Park, increasing the contract price by the sum of \$19,691.00 from \$228,000.00 to \$247,691.00
