NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

**URBAN COUNTY GOVERNMENT:** 

Section 1 - That the Zoning Ordinance of the Lexington-Fayette Urban County Government

be amended to show a change in zone for property located at 362 Newtown Pike from a Light

Industrial (I-1) zone to a Neighborhood Business (B-1) zone for 1.84 net (2.74 gross) acres, being

more fully described in Exhibit "A" which is attached hereto and incorporated herein by reference.

Section 2 - That the Granting of this zone change is made subject to the following use

restrictions as conditions of Granting the zone change:

Under the provisions of Article 6-7 of the Zoning Ordinance, the following

uses shall be prohibited on the subject property via conditional zoning:

a. Animal hospitals or clinics.

b. Drive-through facilities.

c. Automobile repair, service stations and gasoline pumps, closer than

125' from West Fourth Street.

d. Automobile and vehicle refueling stations, closer than 125' from West

Fourth Street.

Section 3 - That the Lexington-Fayette Urban County Planning Commission is directed to

show the amendment on the official zone map atlas and to make reference to the number of this

Ordinance.

Section 4 - That this Ordinance shall become effective on the date of its passage.
