WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$5,000 in the Division of Parks and Recreation from the Council Capital Fund for the design and installation of a memorial for Antonio Franklin, Junior in Duncan Park:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount of \$5,000 in the Division of Parks and Recreation from the Council Capital Fund for the design and installation of a memorial for Antonio Franklin, Junior in Duncan Park and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
