WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for Grant match and establish Grant Budgets from Kentucky Division of Emergency Management:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for Grant match and establish Grant Budgets from Kentucky Division of Emergency Management, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$\_44,246.28\_ \_from\_ the Unappropriated Fund Balance in the General Services District-General Fund \_to\_ various accounts.

) Re-appropriations within the Grant fund that do not result in changes to the Unappropriated Fund Balances of this fund.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein

appropriated, are detailed in "BUDGET SCHEDULE NO. 0026", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.

) \$44,246.28 from the Unappropriated Fund Balance in the General Services District-General Fund to various accounts.

) Re-appropriations within the grant fund that do not result in changes to the Unappropriated Fund Balances of this fund.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0026", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
