Section 2 - That an amount, estimated not to exceed the sum of \$134,624.00 in FY 2024, be and hereby is approved for payment to MED-ENG, LLC, from account # 3200-505505-96708 (\$51,105.00), account # 1105-505501-96461 (\$80,000.00) and account # 1101-505505-75602 (\$3,519.00), with funding for future years contingent upon the appropriation of sufficient funds.
