Section 2 - That an amount, estimated not to exceed \$6,000.00 in FY2025, subject to sufficient funds being appropriated in future fiscal years, be and hereby is approved for payment to Cardinal Valley Park Activity Board, Inc., from account # 1101 - 707606 - 75101, pursuant to the terms of the Concession Agreement.

Section 3 - That this Resolution shall become effective on the date of its passage.
