NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

-) \$_21,414__from_ the Unappropriated Fund Balance in the General Fund Capital Projects to various accounts.
-) \$ 104,283.00 from the Unappropriated Fund Balance in the Sanitary Sewer Construction Fund to various accounts.
-) \$ 3,170 to the Unappropriated Fund Balance in the Landfill Fund from various accounts.
-) \$_12,566.00 _ to_ the Unappropriated Fund Balance in Landfill Construction _from_ various accounts.
-) Re-appropriations within the General Services District Fund; General Fund Capital Projects; Full Urban Services District
