NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to provide funds for purchase orders and pre-paid expenses rolling from FY 2016 into FY 2017, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

various accounts.

) \$5,428,973.70 \_ \_from\_ the Unappropriated Fund Balance in the Full Urban Services District Fund \_to\_

various accounts.

) \$3,150.00 \_ \_from\_ the Unappropriated Fund Balance in the Public Safety Fund \_to\_ various accounts.

) \$3,484,415.79 \_ \_from\_ the Unappropriated Fund Balance in the Municipal Aid Program Fund \_to\_ various accounts.

) \$59,962.04 \_ \_from\_ the Unappropriated Fund Balance in the County Aid Program Fund \_to\_ various accounts.

) \$31,692.60 \_ \_from\_ the Unappropriated Fund Balance in the Mineral Severance Fund \_to\_ various accounts.

) \$9,241.53 \_ \_from\_ the Unappropriated Fund Balance in the Coal Severance Fund \_to\_ various accounts.

) \$1,541,602.60 \_ \_from\_ the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund \_to\_ various accounts.

) \$59.49 \_ \_from\_ the Unappropriated Fund Balance in the Central Kentucky 911 Fund \_to\_ various accounts.

) \$19,500.00 from the Unappropriated Fund Balance in the Medical Insurance Fund to various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0003", attached hereto and incorporated herein by reference.
