WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$195.00 from Neighborhood Development Funds for the purchase and replacement of a damaged right-of-way tree at the Belleau Wood neighborhood entrance:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount of \$195.00 from Neighborhood Development Funds for the purchase and replacement of a damaged right-of-way tree at the Belleau Wood neighborhood entrance and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
