Section 2 - That an amount, not to exceed \$40.00 for each scheduled on-call period, \$230.00 for each completed forensic examination, \$50.00 per case for professional testimony in court, and the reasonable cost of medical liability insurance, be and hereby is approved for payment to Kristin Beers, from account #3140-505506-71299 and #3140-505506-71217, pursuant to the terms of the Professional Services Agreement.
