AN ORDINANCE PURSUANT TO SECTION 2-1(a) OF THE CODE OF ORDINANCES OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, ADOPTING A SCHEDULE OF MEETINGS FOR THE COUNCIL FOR THE CALENDAR YEAR 2021.

WHEREAS, KRS 61.820 provides that all public agencies of the state shall provide for a schedule of regular meetings by Ordinance, order, Resolution, bylaws, or whatever other means May be required for the
