A Resolution authorizing the Mayor, on behalf of the Urban County Government, to execute an Amendment to Agreement with Accela, Inc., and a Supplement to General Terms and Conditions with Springbrook Software, Inc., for service and storage changes to the OLF Business Tax Revenue Collections, Recording and Reporting System, at a cost savings of \$41,284. [Div. of Revenue, Cook] Authorization to execute amendments to the new OLF Business Tax Revenue Collections, Recording and Reporting Systems with Springbrook, aka Acella. The amendment includes converting from a Managed Hosting environment to a Cloud Services environment (resulting in lower annual service fees), changing Sections 2.1 and 3.3 and adding a Service Level Agreement (SLA) between LFUCG and Springbrook, aka Acella, to the original agreement.
