WHEREAS, pursuant to Code of Ordinances Section 18-51 and other authorities, the Division of Traffic Engineering is authorized and empowered to place and maintain traffic control signs, signals, and devices to regulate traffic; and

WHEREAS, pursuant to Code of Ordinances Section 18-86, the Division of Traffic Engineering is further authorized and empowered to designate intersections where stop controls are necessary to regulate traffic; and

WHEREAS, the Division of Traffic Engineering has performed a Decommissioning Study regarding the removal of traffic control signals and the installation of multi-way stop controls at the following intersections: North Martin Luther King Boulevard and East Second Street and North Martin Luther King Boulevard and East Fourth Street; and

WHEREAS, the Urban County Council has determined that the intersection of North Martin Luther King Boulevard and East Second Street and North Martin Luther King Boulevard and East Fourth Street should have multi-way stop controls in lieu of traffic control signals.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Division of Traffic Engineering is hereby authorized and directed to decommission the traffic control signals at the following intersections: North Martin Luther King

Boulevard and East Second Street and North Martin Luther King Boulevard and East Fourth Street; and is further authorized to install multi-way stop controls.

Section 2 - That the Division of Traffic Engineering is further authorized and directed to install proper and appropriate signs in accordance with that designation.
