NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That Section 2-305(1) and 2-305-(2) of the Code of Ordinances of the Lexington-Fayette Urban County Government be and hereby is amended to read as follows:

Sec. 2-305. Duties.

The special events commission shall perform the following duties:

- (1) The commission shall be responsible for reviewing applications on the "Fourth of July Festival," "New Year's Eve Celebration," and other special events, including races, parades, art fairs, etc.
- (2) The commission shall coordinate its event applications with urban county government divisions as necessary.
- (3) The commission may establish committees, headed by commission members, which shall include interested members of the public, for the purpose of carrying out the duties as set forth herein.
- (4) The commission may perform any other act necessary or appropriate to carry out the purposes of this section.

Section 2 - That this Ordinance shall become effective on the date of its passage.
